Apologetics of a long time Catholic:

My years of training in my religion have taught me many, very valuable beliefs. The most important is that we all should love Almighty God above all things and that we should at all times be prepared to give up even our very lives in order to honor that commitment. We know that we should know God, love God and serve Him in this world, so that we may be happy with Him in Heaven. In order to know God, we have an obligation to study all that he has revealed and to abide by all of the laws and commandments which he has given us. We cannot love God until we truly know Him and all that He directs us to do or not to do. We cannot

truly serve Him unless we truly know all that He directs us to do or not to do. We cannot in any way gain Heaven for all eternity, unless we do the same. Next to loving God above all things, we are to love our neighbor as ourselves. This is what is known as true Christian Charity. Charity is the true art of loving someone else as ourselves for the love of God. Charity is not a philanthropic give-away program, as the world knows it today. We hear people say, "Please, I do not want your charity". If they really understood the essence of True Charity, they would want every blessed drop they could possibly receive. In order to love another person as ourselves, we must be as concerned and as helpful to them as we would if we were to observe ourselves in a looking glass. We love our neighbor, that is, every other soul which God has created, as our very selves, even to the point of giving our very lives to save their lives, and more important, to save their souls from eternal damnation. That is the purpose of this letter. You are very dear to me, in that you were also created by Almighty God in His image, and you have your immortal soul to save. I truly desire to save my soul, and I desire to help you save your soul in any possible way in which almighty God has made me capable.

So, may I ask you to exercise the virtue of patience and bear with me and with the length and content of this letter. It has taken ten months of my time to research crucial materials and little-known information which will have a significant effect on what is written here. History has played a singular role in bringing us to the devastating situation in which we find ourselves today. You may not agree with what is written here, but please have the patience to thoroughly read every word, and please understand that this is not merely my own view or personal opinion. What is written is based on unquestionable teachings of Almighty God, His Commandments, and those of His Church. So, please, take the time to find a quiet place, so that you may sincerely concentrate on what is written. Please realize that what you read, and what you do understand, will have, with the help of God and the Grace He gives you, an enormous impact on your spiritual future, here on this earth and for all eternity. Please write to me or call me if you have any questions about anything which is written here. It is so very important. What is written here, you will most likely never see or hear anywhere else. You will most likely never meet anyone else who will tell you, or even care to tell you what is written here. It is a known fact that most people do not want to hear the truth. You have the opportunity to be different and hear the total truth. Please take the time to quietly study this letter. Pray to the Holy Ghost for the Gift of Understanding and for His Guidance. I do believe that this letter is now in your hands because Almighty God has willed it so. Now, let us begin.

The world today is in an incredible condition. Billions of people follow thousands of various "religious" beliefs. Most people think that everyone has the right to believe and to follow whatever one's inclination of belief may be, saying, "Whatever I believe is ok, and whatever you believe is ok. Please leave me to my belief and I will leave you to your belief. Let's go on our merry way thinking as we wish. Everything will be just fine. If I want to believe some of what you believe and you want to believe some of what I believe, that's great. Even if we disagree, we all do agree that we have the right to disagree. Then, I will leave you alone

and you will leave me alone.” Many also believe that everyone is obliged to follow his or her own belief, even if they have been falsely instructed, even if they are following a misinformed conscience, and even if that belief is opposed to the Will of God.

Who ever granted the “right” to believe whatever strikes one’s fancy in the realm of religious belief? Many today say that God granted this “right”, but they can never say where or when. Who ever said that there is strength in diversity? God revealed to us His one Truth. He did not reveal a “diversity” of truths. God did reveal one Truth which contains within it many facts comprising that one Truth. This writer is a Catholic, has experienced fifteen years of formal Catholic education and 68.5 years of Catholic living and she cannot agree with her friends and acquaintances that it is “ok” for them to follow false beliefs which she knows will lead them to definite and lasting harm. When she sees something wrong, she must say that it is wrong and why it is wrong. This, according to Catholic teaching, is the act of charity expressed in fraternal correction. she cannot agree with the prevailing notion that “I’m ok and you’re ok”. It is impossible for this to apply to religion, for God has clearly revealed what is right and what is wrong. Those who wish to defend their “right” to follow their own self-styled or world oriented, man-invented belief are quick to defend themselves against any criticism whatsoever. They are now conditioned to immediately use even the Bible to defend their so-called “right” to believe whatever they wish by saying, “Now, now, judge not, judge not”. What they really mean is that they are happy with their error and do not want to hear the truth, or do not, in fact, love the truth. or even want to love it.

This letter is a small effort by a Catholic layman to explain from her Catholic experience and training why the world is in such an incredible state in these days. It is an effort to explain from her Catholic teaching and experience in order to make clear to those who know her what the truth is and what it has always been. Truth does not change. Human beings change, following every diverse course that presents itself and thus wandering away from the straight way of the truth into thousands of dark alleys and broad paths of man-made error. We will be judged based upon our acceptance of truth or upon our rejection of truth. It is that simple. Our myriad excuses will not suffice on Judgment Day. All of our reasons for our misguided actions will be deemed as blatant rationalizations, and will detract from our standing before Almighty God. We must know when we are wrong and must admit that we are wrong in the sight of God, or deny our God-given conscience.

“Judge not, that you may not be judged” (The Gospel of Saint Matthew, chapter 7, verse 1, Douay Catholic Bible). This is one of the most misquoted, misunderstood and therefore misused verses in the Bible. This is simply verse 1 of chapter 7, and by itself, is easily taken out of context. Continuing the reading of the chapter, we see that we are to judge when it is necessary and appropriate for us to do so. The command to “judge” appears several times in the Bible (for example, Leviticus, chapter 19, verse 15: “Judge thy neighbor according to justice” and the Gospel of

Saint John, chapter 7, verse 24: “Judge not according to appearance, but judge just judgment” reminding us that we must judge “justly” when it is our responsibility to do so. We are not permitted to stand by ignoring the errors of our loved ones who say, “Judge not!” This would constitute, not fraternal charity, but fratricide in the spiritual sense. Satan and the enemies of Christ, in and out of the Church, would be very pleased if we did just that. The facts are very clear. God, through His Church, has already clearly pronounced what is right or wrong. What we do as husbands, fathers, wives, mothers or friends is to correct according to the already-stated judgment of the Church. We cannot sit back in our easy chairs and see error engulf those whom we know and love, and say, “Oh, well, too bad, there is nothing I can do about it. Let’s not concern ourselves. They will be all right in due time.” If we do this, we will answer before God for our lack of required action as if we had committed the same sins which we should have either prevented or corrected. In other words, we become partakers in those sins.

Opinions and “beliefs” with regard to religious principles today are so diversified and watered-down that nearly every facet and detail of the One Truth has been perverted. I will mention some of the most notable misconceptions as they relate (or do not relate) to the truth. Marriage is now considered a temporary “state”. Divorce is accepted as a way of life. Nearly 50% of marriages now end in divorce. These parties, following divorce, then “remarry”. God has commanded and the Church has always taught that marriage is forever and cannot be undone by anything earthly. Those who marry validly, continue to be married until the death of the spouse. There is no past tense. One cannot say, “I used to be married to him or her”, or, “When we were married.....”, or “My ex-husband (ex-wife) used to”. Christ, Our Lord, said, “What God hath joined together, let no man put asunder” (The Gospel of Saint Matthew, chapter 6, verse 19 and the Gospel of Saint Mark, chapter 10, verse 9). Does anyone any longer believe this? Today we see the common practice of attempted marriages outside of the Church. The Church teaches that Catholics are forbidden to attempt “marriage” outside of the Church before a non-Catholic minister, that anyone doing so or anyone formally participating is ex-communicated from the Church by the “very fact” of the action (“ipso facto”), and the attempted “marriage” is invalid. This type of “self-excommunication” does not require a formal declaration by a priest or bishop. This point seems to be widely misunderstood. If a person commits a mortal sin, it is not necessary for that person to be formally accused of the crime. This also applies to “ipso facto excommunication”. If we commit them, we are guilty, and can only be forgiven and exonerated by the local bishop, or in danger of death, by a priest. Even attending the event of an attempted “marriage” outside the Church or even being present at the reception is forbidden by the Church. We have seen several situations wherein relatives or acquaintances who were born Catholic, presented themselves before a non-Catholic minister in a non-Catholic building for the purpose of an attempted “marriage” to a non-Catholic. Our relatives and acquaintances have participated as official witnesses, that is, as Best Man or Maid of Honor, of attempted mixed “marriages” outside of the Church. All Catholics participating in the “ceremony” are excommunicated

from the Catholic Church in the sight of God. It is not required for them to receive a registered, certified document in the mail for this to occur. Relatives and acquaintances have attended both the service and the reception, giving honor to this most dishonorable event. Everyone who attends these “services” and receptions “celebrates” against the will of God, because God and His Church make very clear that there is in this situation no cause for celebration, but clear cause for condemnation. The Church states that these attempted “marriages” are both illicit (not holy) and invalid (not real....as in “do not exist”), that is, they are no marriages at all, that anyone doing this lives in daily adultery, that anyone participating in the event is also guilty as an accomplice, and that continued friendship with those who attempt such an act is an additional sin on a daily basis. All of this amounts to giving respect to human beings by placing them high above the respect due to God and His laws, which are also the laws of His Church. Too many that we know, give family the pedestal position of some sort of god. Family is, in effect, placed above God. We must remember that we must first respect God and His Commandments, and then give our respect to human beings within the context of the Law of God. “Tribulation and anguish upon every soul of man that worketh evil....but glory, and honor, and peace to every one that worketh good, for there is no respect of persons with God.” (The Epistle of Saint Paul to the Romans, chapter 2, verse 9-11) (underlining added for emphasis.). These attempted “marriages” are in no way similar to receiving permission from the priest, as required by the Church, for the purpose of performing a social courtesy by being present at the marriage of two persons who had been born non-Catholic. Non-Catholics are permitted to marry in non-Catholic buildings before non-Catholic ministers, civil judges, magistrates or captains of ships; Catholics are forbidden to do so by Divine and Church Law, no question about it, no exceptions, no excuses, ifs, ands or buts! That is the Church Law wherever civil ceremonies are not first required. In totalitarian countries (Hungary-Czechoslovakia), the civil ceremony is required first, then the religious ceremony is performed.

People become very emotional if they are admonished for doing such a thing. They say, “Judge not!” The truth is that the Church forbids this because God forbids it. The judgment has already been made by God and His Church. It is our responsibility to explain this to those whom we know, because they have either forgotten what the teaching of the Church is on the subject, or never knew it in the first place, or they do not want to remember what is. They will tell us that we have no business at all bringing this to their attention, that is, “none of our business”. Anyone who is vested with the responsibility and duty as husband, father, wife, mother or Catholic friend must do so and that cannot be changed due to emotional sensitivities or any other earthly reason. Our responsibility is to immediately offer the charity of fraternal correction. If we see our children, family or friends walking into the path of a freight train, would we not warn them of the impending danger to their bodies? Are their souls less important? Our souls also share in the responsibility of their actions if we, due to our human weakness, embarrassment or fear, do not offer them proper correction. “But if thou give warning to the wicked, and he be not converted from his wickedness,

and from his evil way: he indeed shall die in his iniquity, but thou has delivered thy soul. Moreover if the just man shall turn away from his justice, and shall commit iniquity: I will lay a stumbling block before him, he shall die, because thou hast not given him warning: He shall die in his sin, and his justices which he had done, shall not be remembered: But I will require his blood at thy hand.” (The prophet Ezechiel, chapter 3, verses 19 and 20) These poor souls will accuse us on judgment day if we do not correct them now. Many of us have experienced, on different occasions, relatives and acquaintances born Catholic, having no qualms at either “officially” participating in such services, attending the services and/or going to the reception or sending a “wedding” card of congratulations to the participants of the “ceremony”.

This open and public denial of their once-professed Catholic belief of the Catholic requirements of marriage offers a striking comparison with those who have given their lives as martyrs in defense of the Faith. One example that comes to mind in the Old Testament is the reading of the seven Machabees, (2 Machabees, chapter 7, verses 1-20) who refused to eat swine’s flesh when they were commanded by the king to do so. They said, “We are ready to die rather than transgress the laws of God, received from our fathers.” Their mother encouraged each one of them to die manfully. Then she was killed. All they had to do was to eat a little flesh of the swine (pork, bacon), and they could have saved their lives! But, no, they were aware that the law of God cannot be transgressed for any reason, and they were willing to give their lives to honor God. They did not make any excuses for themselves. They did not say, “Well, eating swine’s flesh could not possibly be that important, that we should give up our lives. Let’s eat it. God will understand, and He will change the law for us. He will make an exception for us. Surely he does not want us to die for such a small thing.” Instead, they demonstrated their holy fear of God and His Law. Today, it seems that people are more willing to die to defend their “right” to transgress the laws of God and His Church. Those who have the responsibility to give good example, must do so in such circumstances. We are not permitted to bend with the wind of worldly opinion and human respect and to act defiantly against the commands of God and His Church. We seem to think that we no longer have to answer to anyone or to any laws, or that we may choose those laws which are agreeable, and reject those which we do not find agreeable. We act as if the law was, of course, not made for us, that God certainly understands how we feel and that we are excused, since abiding by the law would certainly be too difficult for us. The prevailing “feeling” is that our sons or daughters are now “mature adults” and they have the “right” to choose whatever they wish and that we, as parents or relatives, should go along so as not to cause dissension, whereas, in truth, no one has the “right” to choose evil. Today, it seems that unity with friends and relatives is more important than conformity to the law of God. Almighty God and His Church disagree with our “feelings” and our lack of steadfastness in our faith. What would have happened to Saint Augustine if his mother, Saint Monica, had not pursued him for years while he was following pagan philosophers, living as a pagan and living with a woman outside of marriage, by whom he had an illegitimate son, whose name was Adeodatus? He would have remained a pagan,

died in sin and would probably have gone to Hell. Her prayers and the Grace of God were the reasons that Saint Augustine became a Catholic, a priest, a bishop, a great saint and a “Doctor” of the Church. What would have happened to her husband, Patricius, a life-long pagan, if she had not perseveringly explained to him the truths of the Catholic religion? If she had not made the effort, would he have been converted and baptized the year before he died? It seems that the insidious deceit of women’s “lib”, pluralism (I’m ok, you’re ok.”, all religions are ok or almost ok), and the error of freedom of conscience have taken a heavy toll upon most of those whom we know, including members of our own families. To those who teach it, “freedom of conscience” means that everyone is free to do as he or she pleases in opposition to the law of God and the teachings of His Church. What it really means is that they want everyone to be set free from the restraints placed on them by the laws of the Church. About fifteen years ago, relatives and acquaintances were invited to a party hosted in Cleveland by a popular television talk show host and his new “bride”, also a celebrity. The talk show host had recently divorced his wife of many years. It was explained to them that attendance was not permitted because these two publicly known once-Catholic celebrities had notoriously attempted “marriage” outside the Church in the living room of her once-Catholic father. It was “attempted marriage” because the Church states very clearly that this action is invalid. (Characters involved were Phil Donahue, friend of the family, Marlo Thomas and Danny Thomas.) If he attempted to get an “annulment” of his real marriage from the “new church”, that would have been in direct opposition to the teachings and practice of the true Catholic Church. This same talk show host published a book in which he describes much of his Catholic upbringing and experiences, including his education at the Catholic university of Notre Dame and then publicly proclaims that he is an anti-Catholic and an atheist. He said so very clearly in his book and also on television. We have an audio tape of that very television program. One reads, listens and weeps at the words and thoughts of one who was once a Catholic, who grew up in our old Catholic neighborhood, who has lost his faith to the deceptive errors of the world and is now an avowed atheist. All who attended the party (including his mother and my son’s in-laws) for whatever reason, gave public outward honor to the “new couple” and their views and actions and even more important, gave open dishonor to the Catholic Church, which has always forbidden what they did, and continues to do so to this day. Faithful Catholics have always known that they should refrain from any such association with heretics and public unrepentant sinners and would, without hesitation, refuse an invitation to attend, knowing that the act of attending dishonors what Catholics believe, gives bad example to others, and cannot in any way be justified just for the “thrill” and “personal honor” of being at a party with television and Hollywood celebrities. We have seen once-Catholics send, or want to send, their children to non-Catholic bible schools, summer camps, and “Christian” academies. We have seen once-Catholics attend, or want to attend, non-Catholic “confirmation” parties and other “parties” celebrating assorted non-Catholic “religious” occasions. These non-Catholic organizations have no valid priests or bishops. How can we give honor to them or to the belief of those who follow them as if they do have the sacrament of Confirmation when they do not? The

reason it is done, is that we do not want to disturb our “friendly neighborly relationship”, that is, we place human respect above the law of God. The Church teaches that those who continue to believe this way and who continue to act in such a manner must be avoided because they are suspect of heresy, and therefore suffer the loss of faith in the true Church, and potentially, the loss of their immortal souls.

This error is called Indifferentism. We, because of the influence of our pluralistic society and of the new super-ecumenical, incorrectly called “Catholic Church”, cater to the honor and glory of man through human respect (false ecumenism) instead of keeping God’s laws sacred as we should (Catholicism). We are so afraid of what other people will say if we do not “go along”, when we should hold a holy fear of betraying our own Catholic beliefs. We have mentioned to once-Catholic relatives and acquaintances that they should not be working on Sunday, because it is not necessary for them to work on that day to support their family. The Church teaches that unnecessary servile work is not permitted on Sunday, because the Third Commandment states that we must remember to keep the Sabbath Day holy. Sunday is a day of required rest and holiness. The breadwinner is permitted to work on Sunday only if it is absolutely necessary for the support of the family. It has been mentioned to once-Catholic girls and women many times about the pagan clothes they wear. These fashions are not ladylike, Mary-like, Catholic or even basically decent. This advice is ignored because they cannot bear the thought of looking different from their pagan friends, to whom they must appear identical in their apparel. They do not feel comfortable looking different or being criticized by their friends for not wearing their latest styles. They have a driving compulsion to observe the current style no matter how offensive it is, just to “be in style”. Most girls today wear some of the most hideous clothing in public and even in church. They paint on blue jeans which are so tight, it appears that they have blue skin instead of any clothing on at all. Their mothers defend these fashions by saying, “Well, they are covered up, aren’t they?” Then these mothers wear the same styles to “keep up” with their daughters, compounding the insanity by giving bad example, and by degrading themselves. Girls wear shorts and leotards which reveal everything and leave nothing to the imagination. They wear the latest beach styles which make lingerie appear modest. Nearly naked is now accepted as “modest”, or even “cute”. Then these mothers wonder why their daughters, or even they, are raped. Both fathers and mothers condone these immodest fashions by allowing their continued use, sometimes because they do not care, and in all instances because they have lost the grace which would give them the fortitude to prevent such pagan practices from occurring in their very own families. The Middle East has for centuries adhered to the custom of covering even the female face. Only the woman’s husband is privileged to view the beauty of his wife. The West, of course, follows no such custom except to encourage the revealing of not only the woman’s cheeks on her face, but everything else, for public exposure. The fashion industry is controlled by pagans, who produce the uniform of pagans for pagans. If we do not believe that we belong to the pagan army, then we should not be caught wearing their uniform. We could die in their uniform, being caught

behind enemy lines and be proclaimed as pagan heroes.

Scripture long ago set the required moral tone for modesty in fashion and public comportment. In A.D. 66, Saint Paul, advising Saint Timothy, the bishop of Ephesus, with regard to the proper leadership of his flock said, “....that we may lead a life of peace and chastity....I will therefore that men pray in every place, lifting up pure hands, without anger and contention. In like manner women also in decent apparel, adorning themselves with modesty and sobriety, not plaited hair, or gold, or pearls, or costly attire, but as becometh women professing godliness, with good works.” (The first epistle of Saint Paul to Saint Timothy, chapter 2, verses 1, 8, 9, 10). The Old Testament book of Deuteronomy, the second book of the Law of Moses, inculcates the ordinances given by God to Moses on Mount Sinai. The law clearly points out that there must be a definite difference in the apparel worn by men and women: “A woman shall not be clothed with man’s apparel, neither shall a man use woman’s apparel: For he that doeth these things is abominable before God.” (Deuteronomy, chapter 22, verse 5). The Catholic Church, in conformity with scripture, consistently teaches the laws which must be followed with regard to modest apparel. Do we hear this advice preached from the pulpit today? Certainly not! Who was it who first decided that women would wear pants? It was not someone interested in obeying scripture and the laws of the Church. It was the pagan fashion trend setters. They now have women all over the world wearing pants, looking as if they just walked out of a coal mine. These “fashion experts” have deliberately and successfully downgraded women. They have destroyed their feminine uniqueness, dignity and self-respect. Nowadays, there is no need to ask who wears the pants in the family, as almost everyone is wearing them, bearing the pagan “coat of arms”. These fashion “experts” have successfully indoctrinated the minds of most women with the desire to bear arms and the brunt of the workforce rather than with the desire to bear children. They have succeeded in reversing the role of women from that intended by Almighty God. It is interesting to observe how many women now find themselves, clad in military fatigues, assigned to the sweltering heat of a Middle East desert. “Yet she shall be saved through child bearing; if she continues in faith and love, and sanctification, with sobriety.” (The first epistle of Saint Paul to Saint Timothy, chapter 2, verse 15). What ever happened to the desire to steadfastly follow the will of God in all things? It disappeared with the loss of Grace. These abominations do not occur just because “That’s the way the world is today.” The world is the way it is today because of the loss of Grace. This is the sole reason these abominations occur. The loss of Grace is the reason that most people accept these abominations as the ordinary “thing to do”. Grace gives the “Christian sense” to realize the difference between pagan abominations and Christian Truth and the strength to fight for the Truth and to hold firmly to the Truth.

Christians are supposed to be soldiers of Christ, thus belonging to a very different, special army. Being such, we must wear our own uniform which distinguishes us as such. We must wear fashions which are modest, which clearly say that we are Christian. If we have to make our own clothes to achieve that

objective, then we should do so. Most immodest fashions for women are designed by homosexuals, who detest women and who want to debase women by means of the designs they create for them to wear. Two of the most famous of these recently died of aids. May God have mercy on their souls. These pagan fashion designers constitute an example of the unrelenting attack by the enemies of God and of His Church. This attack is nothing new. It has existed for centuries and manifests itself in new and various forms throughout the years. These designers know that they can change the inherent values of the public by changing their styles, by changing their fashions. The old saying, "You are what you eat." applies in the same manner to clothing: "You are what you wear." Fashion is an outward statement of the inner belief. The same theory exists in the hair fashion industry. These stylists are glad to charge women \$50.00 for a perm which makes them appear as if they just spent an hour in a blizzard or a torrential thunderstorm. Unfortunately, men and women have been conditioned to be more than willing to pay any price to have themselves look like pagans. They will even pay the price of their souls.

Pluralism has had such a devastating effect on the conscience of this country that the level of the comprehension of Christianity in the mind of the average person has been reduced to a point of non-recognition. Those who should know better devote themselves to the law of the land, party going, human respect and the "pied- pipered" following of their friends and the latest trends, instead of to the law of God. Once-Catholics now pay unbelievable sums of their hard earned money to attend rock concerts, trashy R-rated movies and to purchase or rent the latest indoctrinating garbage offered by the recording and video industries. Sums of money are spent to purchase trash-filled books, written by pagan (hedonistic) authors. This is accomplished without realizing that they are offering incense to false idols with every penny spent. They resort to imaginative resources to make sure they get a prime seat and the autograph of their favorite stars. One of these that comes to mind is a popular female "folk gospel" singer (Amy Grant). Why would someone who thinks he or she is a Catholic want to go to all this trouble to get a prime seat and the autograph of such a person? Yes, she seems sweet and innocent. She's very popular. In reality, she is an active, public promoter of false religion. She is a public heretic. In fact, she is not what she is promoted to be. She is a heretic, and an enemy of God and His Holy Catholic Church. One penny spent for the benefit of such a person and for her ministry is equivalent to offering incense to a false idol. That is a serious offense against the First Commandment of Almighty God.

Our country has been degraded to the nadir of neo-paganism. Millions now support abortion, making hundreds of excuses that murder is now acceptable. The right of "choice" is now the dominant thrust. Thousands of those who think themselves Christian, support the woman's "right to choose", to choose to murder her baby? One third of those in Congress who are known as "Catholic" support the woman's "right to choose" murder, and how many others are there who also consider themselves to be "Christian" who do the same? Imagine how base and twisted minds have become, that men, women, doctors and attorneys can

produce hundreds of reasons to support their cause for murdering unborn children. The rationalization has gone so far that millions believe that an unborn child is not a child at all, but simply a non-human embryo, now referred to as a “fetus”. There is more excitement and interest generated for soap opera type television shows than there is for one thought with regard to eternal salvation. If this nation chooses these kinds of trash as its favorite pastime entertainment, then this nation’s morals reside in the trash dump. A nation which supports immorality is in decay, and at the point of collapse. This nation and its media spend more time adoring sports of any kind than is spent honoring God. People become so enthralled with the sports mania that they riot in honor of their team’s victory. This happened during the three most recent championships in Michigan. In 1984, the Detroit Tigers won the World Series. The crowd nearly burned down the entire Michigan Avenue / Kaline Drive neighborhood. In 1989, the University of Michigan won the NCAA basketball championship. Thousands of students poured out of Ann Arbor bars causing a twelve hour riot resulting in hundreds of injuries and thousands of dollars in property damage. In addition to that, scores of students streaked naked down Ann Arbor streets. In 1990, the Detroit Pistons won the NBA basketball championship. The fans, in their unbridled enthusiasm, rioted. Seven people were killed during the “celebration”. Would we say these events and experiences are what we would expect to occur in a so-called “Christian” nation”? No, we are a nation of post-Christian neo-pagans.

Why can’t we be different and please God instead of our friends and our own likes and desires? Why can’t we be different, be truly Christian, and detach ourselves from the allurements of this world, where we are on trial for only a very short time, and by persevering, thereby save our immortal souls? Why? Because the strength and protection of Grace has been lost. We are also what and how we pray, or do not pray. The law of prayer is the law of belief (*Lex orandi, lex credendi*” is a famous theological axiom.) Change and pervert the prayer, and Grace departs. As Grace departs, paganism enters. This was accomplished with the change in the words and the format of the Mass. Thousands of Catholic books, all that we were ever taught and all that we read now, from the same Catholic sources in our substantial library, express exactly the same thoughts that are expressed here. God’s Church does not change to keep up with modern man. God does not change. God and His Church do not become pagan because the world will not listen. We must hold to what the Church teaches as it always has, even if a pope, cardinal, bishop or angel from Heaven appears and says differently. (Epistle of Saint Paul to the Galatians, Chapter 1, verses 6-9, “but though we, or an angel from Heaven, preach a gospel to you besides that which we have preached to you, let him be anathema” (cursed). Saint Paul continues to warn of those who distort the Gospel to turn it into a man-pleasing “teaching” which is what the world has today-the social gospel of man, to honor man for man’s sake, using God to advance liberalism, false humanism, socialism and communism. We did not write these books. My parents did not write these books. The Church wrote them, guided by the Holy Ghost, the Finger of God. All of the 3,000+ books we have (many that we do not have were burned) were systematically thrown out of seminaries, schools, churches, rectories and

convents to make way for the new teachings of the new religion, which is false to its very core.

The current state of the world is due to the overall departure and lack of Grace which is due to the loss of the Sacraments of the One True Church. History does repeat itself. Many people do not want to face this most important fact. Constant revolutions and rebellions demoralized and destroyed the Jewish faith of the Old Testament to the point that the Jews did not recognize their very own long-awaited Messiah when he did come to save them. Instead of rejoicing and following Him, they put Him to death. This spiritual blindness was self-induced by their unfaithfulness to the law. The seeds of blindness were planted and inculcated by their very own unfaithful spiritual leaders, their kings, high priests, scribes, Pharisees and false prophets and teachers. Imagine that we were among the Jews of that time. We would have respected the decisions and the leadership of the High Priest, Annas, and his son, the Chief Pharisee, Caiphas. We would have respected and followed the decisions of the Sanhedrin. Where would we have stood when they decided to press on to have the Messiah crucified? They did it by telling the people that Christ was not the Messiah, but a blasphemer, which, of course was the complete opposite of the truth. They lied. Most agreed and accepted their direction with complete, unquestioning trust. After all, they were the great, respected leaders of the one true religion of that time. Why question them, even if the scriptures disagreed with their actions? After all, we would have accepted their word, because they were the experts in charge. The scriptures foretold all of the events of the day, even to the very city in which the Messiah was to be born. Political advantage and the lust for power led the great religious leaders of that time, as well as their followers, to pervert the scriptures and to deny the prophecies. With Caiphas, they believed it expedient to sacrifice one man, one trouble maker, rather than endanger themselves and their Jewish nation. Where would we have stood? Would we have been among the mere 120 who believed and followed Christ, or among the many thousands who followed their mistaken religious leaders? Would we have remained in the Synagogue in which we had worshipped for a lifetime or would we have left it for the Truth, for Christ? Would we have stayed with our friends who said that we should not go against the system that the high priest, the Pharisees and the Sanhedrin could not be wrong, or would we have ignored all of this seducement and followed the Truth with the very few who were doing so. Would we have risked ridicule and persecution? The majority of the Jews gladly followed their traitorous leaders instead of following the law, as they knew it. Any time there have been attacks on the Church of the Old Testament or that of the New Testament, these rebellions and revolutions have been instigated from within by its very own leaders. Whenever this did occur, no one was willing to admit it, to realize it or to recognize it, because they themselves had become infected with the dreadful disease of spiritual blindness which prevented them from seeing what had happened and what would further happen from that point. They resisted any one who stood up to remind them of the Truth and point out their error. They even went as far as to murder the prophets God sent to them to remind them of their errors and to call them back to the Truth of the unchanging Law of God.

This very same unfortunate condition exists today. The very leaders who are entrusted to guard the deposit of Faith and to lead the Faithful to Heaven, have rebelled, becoming the enemy itself, and they are paving the path to Hell for their followers. The enemies are, as they have always been, priests and bishops of the Church. They, as has been the repeated case in history, create the heresies and lead the Faithful away from the Church. No heresy has ever been started by a lay person. The Faithful are seduced into a stupor or misguided false trust in their spiritual leaders and seem to be willing to follow them, even to Hell. The Faithful fall into these heresies without objection, become infected with the disease of spiritual blindness and immediately become the unfaithful. At first, a few fell to the heresies, then more and more, and today, most have fallen. The great difficulty now is that spiritual blindness is so deeply imbedded, that very few will ever see their error, or be willing to admit it. Therefore, many will perish and very few will be saved, just as Christ Himself has foretold. The current conditions are so depraved, that the majority of people in the world place their complete trust in the world alone and in its allurements. People are so removed from the Grace of the True Church of God that any one who attempts to explain the situation to them for their own benefit is looked upon with scorn and rejection. But of course, this was the experience of Christ Himself during His first coming. Conditions are now ripe, as He Himself had foretold they would be, for His second coming. We will stand before the Tribunal of Christ and answer if we have not warned against this apostasy. Here is the warning: "Hear instruction and be wise, and refuse it not." (The book of Proverbs, chapter 8, verse 33) No "sacred cows" will be spared. The honor of the Church of Christ is at stake. Our eternal salvation is at stake. Follow the world and we lose our immortal souls in Hell forever. Follow the Law of God and His Church and we shall win the crown of eternal salvation. The time is now at hand. It matters not whether we are protestant, Jew, Muslim, pagan, or if we think we are a "Catholic" of the New Ordo sect (Novus Ordo) under "John Paul II", Christ will ask us all the same question on the Day of Judgment: "Why were you not a member of My Church?" We will not be able then to make the excuses that we make now. We will not be successful in saying, "My mother, my father, my wife, my husband told me, my priest told me, my minister told me, my Rabbi told me, or anyone told me that this was right." Only Truth will be right and accepted as Truth; no distortions, no excuses, only the One True Church or the desire to be honestly part of it will earn us our reward. It makes no sense whatever to take any chances by playing Russian Roulette with our souls. There is only one right way, and that is the only way that God has ordained for us to reach Heaven. God is all-merciful while we are yet on this earth, giving us every opportunity to find that right way. When we reach the final judgment, only Justice will prevail. We will not be permitted to say then, "Oh, well, I did my best. I tried, but did not really understand, God will now understand."

It is so crucially important to understand that all error which leads us away from God is of the Devil, who is the ultimate master of deception. Those who have been led away from the Truth in the past, have been led away by unfaithful

priests and bishops who, in fact were false prophets and false teachers. Their followers, down through the years, are the ministers and members of every sect which claims its own “reformulation” of Christianity. This includes all whom the world honors as “religious leaders”, whether it be Billy Graham, Jimmy Swaggart, Robert Schuller, Fred Price, “John Paul II”, “Mother Teresa”, and thousands of others who have placed themselves and their “flocks” outside of the only Church founded by Christ. A brief review of the history of the Church will show that repeatedly this has been the case. There is nothing new under the sun (The Canticle of Canticles). These attacks on the Church and its teachings did not start just a few years ago, but during the very first years of Christianity, as Saint Paul says. Even before the Apostles died, budding heresies were infecting the new faithful Christians. Following the death of the Apostles, heresies spread abundantly. The fury of Hell has increased and multiplied ever since. The bishop of Antioch, Paul of Samosata, was condemned at the Council of Antioch, let by Pope Saint Felix I, in 269 A.D. for teaching the heresy that Christ was a mere man, in whom the Divine Word dwelt by its operation and as in its temple. Please just imagine if this Paul of Samosata were our local bishop. What would we have done? This condemnation did not kill the seed of the heresy, for it blossomed in the fourth and fifth centuries as the Church was plagued by Arianism. Nearly 90% of the bishops at that time deserted their Catholic Faith and became Arians. Saint Jerome, the revered “Theological Doctor” of the Church, who spent thirty years of his life in the desert translating the Bible, said, “The whole world groaned and marveled to find itself Arian.” The heresy was adhered to by priests, bishops, archbishops, cardinals and emperors. The heresy taught that Jesus Christ was not actually the Son of God, the Second Person of the Blessed Trinity. The heresy was started by a Father Arius, a Catholic priest from Alexandria, Egypt. Many did not really believe the actual teachings of Arianism, but politics was involved and thousands became entangled in the heresy because of their attachment and allegiance to their emperor, the ruling party, their country, the church building to which they belonged or to their friend’s or relative’s beliefs. Please, imagine again, that we were among the followers of Arius, or the thousands of priests, bishops or even the emperors who followed this heresy. They all had been Catholics. We believed in them. We trusted them with our spiritual care. What would we have done when they all fell into error? Saint Athanasius said that the Arian heretics “have the buildings (the churches), but we have the Faith.” To the outside world, the Catholic Church appeared to be the organization that possessed the buildings and the hierarchy. But, in fact, it was not. It existed in the souls and in the Faith of those who still held the True Faith. The buildings and the organization had nothing at all to do with the true residence of the Faith. Thousands and thousands of the Faithful were deceived and seduced by their spiritual leaders and thereby were lost to the error and many were martyred who opposed the insidious error and kept the Faith. These were the few who knew their Faith well, and were not deceived or seduced by the new worldwide false doctrine. In which camp do you think we would have been? God fortunately raised up great saints to battle Arianism (Saint Athanasius, Saint Augustine, Saint John Chrysostom, Saint Hilary and many others.) The Arian influence continued for more than 300 years

(approximately 300-650 A.D.), but these many saints provided the clarity needed to understand the falseness of the heresy. Finally, the battle was won for a time. The Arian heresy evolved into semi-Arianism which was even more difficult to perceive.

Nestorianism appeared in the fifth century. Nestorius, the Catholic Bishop of Constantinople, while fighting heresy, fell into his own heresy. He denied the real unity of the Divine and Human Natures in the Divine Person of Christ. He taught that there was only a moral union of the two Natures. He therefore denied that the Blessed Mother could be called the Mother of God. Please imagine again now, this is the Bishop of Constantinople, the glorious and magnificent religious and governmental center of the East, the equal of the previous majesty of Rome. Constantinople had everything. Its bishop was considered second only to the pope. Please imagine if we were among his devoted followers. Would we have naturally followed him? Would we have stayed in the same church building in which we had always been, even though it had deceptively changed its teachings and allegiance? The heresy of Nestorius was finally condemned at the Council of Ephesus in 431 A.D. and at the council of Chalcedon in 451 A.D.

Pelagianism was introduced in 400 A.D. by Father Pelagius, a Catholic Monk. He taught that Grace was not necessary to salvation, that man's free will and good works were all that were necessary. He denied that original sin is passed on to the descendants of Adam. His heresy reduced everything to the natural level (one of the first "Catholic" Naturalists!). Pelagianism was also condemned at the Council of Ephesus. Although there were others, Saint Augustine was the chief combatant of this heresy.

In 879 A.D., the Church suffered The Great Schism between the East and the West, between Constantinople and Rome, between the Greek Rite and the Latin Rite. Thousands of souls were lost because of politics and one Latin word which is found in the Credo of the Mass. That one Latin word is "filioque", meaning "and the Son". This was written into the Nicene Creed about 450 years following the Council of Nicea of 325 A.D. It was added to emphasize the Divinity of Christ against the Arian Heresy, which denied the Divinity of Christ. The phrase reads "...the Holy Ghost...who proceeds from the Father and the Son"- "Ex Patre filioque procedit". This phrase was not in the Creed as promulgated by the Council of Nicea, but was always believed. Photius, an illegally installed Patriarch of Constantinople, objected to the "filioque" clause, claiming that the Holy Ghost proceeds only from the Father, not from the Son. Photius used this claim as a pretext for his real reason which was to generate unrest between the East and the West to further his political ambitions (the East, Constantinople, and the West, Rome, were the two power centers of the Roman Empire at that time.) Catholic teaching states that the Holy Ghost proceeds simultaneously from the Father and the Son. The people of the East did not really believe in the theory of Photius, but millions followed the political break with the West and now, under the leadership of the Eastern Orthodox Church, believe in the heresy that the Holy Ghost proceeds only from the Father. Millions, nearly half of the

then Catholic World, were again lost to schism and heresy, while many who retained the Catholic Faith were martyred (put to death!). In a typical reversal of Catholic practice, “pope” “Paul VI” (Montini). In the 1960s eliminated the requirement of the Easter Church to include the “filioque procedit” phrase in their creed. And in the 1970s, “pope” “John Paul II” told the Russian Catholics to attend Russian Orthodox Churches. This was done, as were many other of their anti-Catholic actions, in honor of their heresy of False Ecumenism, practiced widely today throughout the new religion referred to as “catholic”.

In 1350 A.D., nearly 200 years before Martin Luther, John Wyclif (1320-1384), a Catholic priest, misnamed the “Morning Star of the Reformation” advanced one of the currently fashionable non-Catholic/anti-Catholic ideas. Father John Wyclif taught that the Bible alone is the sufficient rule of Faith. Supporting belief in an inward and practical religion, he denied the divinely established authority of the pope and bishops of the Church; he also denied the Real Presence of Christ in the Holy Eucharist, and wrote against the Sacrament of Penance (Confession) and the Doctrine of Indulgences. Eighteen of his propositions were condemned by Pope Gregory XI (Pietro Roger De Beaufort, 1370-1378). Father John Hus, a Catholic priest from Bohemia, (now Czechoslovakia) preached the teachings of Wyclif, circa 1400 A.D. Both Wyclif and Hus were convicted of heresy and their teachings were condemned at the Council of Constance in 1415 A.D. Hus, still living at that time, was formally excommunicated from the Catholic Church.

In the sixteenth century, the Church experienced the fury of Hell in the attack by the rebels of the Protestant revolt (so-called reformation). Entire countries were lost to the errors of Martin Luther and King Henry VIII. Thousands of Catholics again gave their lives for the Faith rather than bow to the honor of the king or to the hideous perversions preached by Martin Luther and his many followers. Both of these apostates and heretics, and many to follow, attacked the Mass and the Sacraments, offering substitutions which appeared very similar to the real thing in order to deceive many, but are actually worthless. Communal services were introduced, using new prayers to support the new theology and liberated thinking. Spontaneous prayer was introduced, that is, one says whatever one thinks or feels at the moment or for the situation at hand. All references to sacrifice were systematically removed. Latin was eliminated and services were said in the native tongue (the vernacular). Principally for the protection of doctrine, the Church has wisely used Latin in the liturgy because it is an unchanging tongue, thus avoiding the variables in language differences found in the vernacular or common tongue of the people. The Council of Trent declared anathema (cursed) anyone who said that the words of the Mass should be said in the vernacular. Consider the difference between “visible and invisible” versus “seen and unseen”! Consider the difference between a gangster asking a bank teller to “pass over the bread!” versus someone sitting at the table asking “Please pass the bread.” Consider the current misuse of the word “concert”. “Concert” used to mean attending a performance of the symphony orchestra. Now that term is perverted to apply to a rock concert or a rap concert. The Greeks of the Eastern Uniate Rite (Catholic) used classical Greek for the same reason, to

protect doctrine against the various possible meanings of words as they change, with dialects and day to day slang used in the various common modern languages. Altars were destroyed or placed in the background, because the altar represents sacrifice. The use of altars was replaced by the use of tables. The table represents a meal, a memorial meal. The table is also a place for an exhibition, a presentation or a show, not a place of offering. The new ministers of the new religions turned their backs on the altars to face the people, a very definite symbolic act representing the turning away from the only religion which honors God to a new religion which honors man (Humanism). Sacraments, statues, pious devotions, Sunday Mass obligation, and most forms of mortification including fasting and abstinence were eliminated. Churches were burned, sacked and destroyed. Monasteries were destroyed and the church's property was confiscated. Monasteries and convents were not to be part of the foundation of these new religions. The discipline and sanctification which they represented were purged from the new religions. Church buildings which they decided to keep were renovated and de-Catholicized. The Bible was rewritten to reflect the desired updating and the new liberal theology. New hymns were written by the reformers to introduce their new theology to the people. Everything was modernized to please their worldly desires. No one was obliged to do anything or believe anything. Celebration of liberty and freedom was the underlying tone of the movement. Innovation followed innovation. Error followed error. Reform followed reform. All these actions were, of course, against the laws of the Catholic Church.

All these activities did not occur at once. The people would have revolted if all of these drastic changes had happened at once. It is most important that we have a correct sense of history so that we may understand what did happen, how it happened and why it happened. All events of the Protestant Reformation, the revolution which it involved and all of the changes which followed, occurred over a period of many years through the process of gradualism, one step at a time, here and there. The people accepted one little change, not thinking much of it, which prepared them for the next little change and the next little change. Years later, following many little changes, they had accepted one big, overall change. This is the deceptive process of Gradualism, Patient Gradualism. It is a well planned process of indoctrination.

Martin Luther, a Catholic Augustinian monk and a Doctor of Divinity, well known for his lectures on the Bible, became upset about what he considered abuses or unfairness in the distribution of Indulgences. In 1517, he posted his ninety-five theses on the front door of All Saints Catholic Church in Wittenberg, Germany. Germany was a Catholic Country. Posting notices on the door of a church or other public buildings was the common practice of announcing one's views at that time. These theses, written in Latin, listed what he considered to be abuses. These were eventually translated into German and then into other languages and distributed throughout Europe with the help of the new invention, the printing press. Following two years of lengthy discourses with the pope, and his refusal to obey the papal bull, which he publicly burned, he was formally excommunicated from the Catholic Church. He then published articles denying the supremacy of

the pope and monastic vows and, with that, he formally started his own religion, the Lutheran Church, in 1522. In 1525, he attempted marriage with a former nun, Katherine Von Bora, by whom he fathered six children. He completed the writing of his bible by 1534. He had several politically influential friends who sided with him and supported him in his religious errors. With this political base support, the new religion of Lutheranism spread throughout Germany. Few Germans understood his theological teachings, but became entangled in the political feuds between the many German princes and followed whatever their particular prince believed. Nationalism became the gradual influencing factor, overcoming loyalty to the Roman papacy and the leadership of the true Catholic Church founded by Christ. Catholic churches, under the new leadership and influence of their now heretical pastors became Lutheran churches. Thousands of people who thought they were still Catholics, stayed in those buildings, feeding on the new heretical deceptive poison, and unknowingly became Lutherans. We ask ourselves, what would we have done, if we had been living during this period in Germany? Soon this influence spread across the mainland of Europe and beyond, to England.

In 1527, Henry VIII, the Catholic king of Catholic England grew tired of his wife, Catherine of Aragon, because she did not bear him a son, and because he was attracted to her personal maid, Anne Boleyn. Anne was actually Henry's daughter, conceived by his sister. Yes, royal family incest! He petitioned Pope Clement VII to grant an annulment of his marriage. The pope refused, because this is against the law of God and His Church. In 1529, he dismissed his Lord Chancellor, Cardinal Wolsey, who, as a cardinal, was the representative of the pope in England. He appointed Sir Thomas More, educated at Oxford University, as his new Lord Chancellor. Thomas More resigned in 1532, because of the king's argument with the pope. In 1533, Henry secretly "married" Anne and then appointed Thomas Cranmer as Archbishop of Canterbury. Cranmer formulated new church laws which permitted the formal "marriage" of Henry to Anne. In 1534, the Parliament, under the direction of the king, passed laws which enacted the formal break with the Roman Catholic Church and declared Henry VIII the supreme head of The Church of England. Thomas More was asked to sign the document and to recognize the "marriage" between Henry and Anne. He would not do so, and was beheaded in the same year. We now know him as Saint Thomas More, patron of attorneys. By 1539, the government completed the seizure of all church property. Cranmer proceeded to formulate the new religion of England. He wrote the Book of Common Prayer replacing the Roman Missal used in the Mass, and wrote his own version of the bible, replacing the Catholic Bible. Under the reign of King James I, the bible was rewritten into English verse, following Archbishop Cranmer's interpretation, between 1603-1611 by scholars at Oxford and Cambridge, all of whom were now solidly non-Catholic. This new version is called The King James Version. To illustrate the incorrectness of the original King James Version, centuries later, the English Prime Minister, Benjamin Disraeli (1804-1881), a convert from Judaism to the Church of England, said, with regard to these non-Catholic translations: "We find abundant errors reducing the text to nonsense or blasphemy, making the scriptures contemptible to the multitude who come to pray and not to scoff."

Modern non-Catholic translators have sided with Disraeli. Thirty-six thousand changes in the revised King James Version have been made. Many of these changes corrected obvious distortions. Unbiased scholars of the sixteenth century detected these distortions without any hesitation. Ordinary people, however, lacking the ability to read the Hebrew and Greek texts, easily fell into the mistaken opinions aimed at them by dishonest and incompetent translators.

Let us examine two examples of the King James Version mistranslations. In the First Epistle of Saint Paul to the Corinthians: Chapter 11, verse 27, we read in the Catholic Douay Bible:

“Therefore whosoever shall eat this bread, or drink the chalice of the Lord unworthily, shall be guilty of the body and of the blood of the Lord.”

A footnote explains “verse 27”, or drink. Here erroneous translators corrupted the text by putting and drink (contrary to the original Greek text) instead of or drink.

The King James Version reads:

“Wherefore, whosoever shall eat this bread and drink this cup of the Lord, unworthily, shall be guilty of the Body and blood of the Lord.”

One word, AND, makes a big difference. The use of AND would lead one to believe that they would be guilty if they were to unworthily eat and drink. Whereas, the true meaning of the text is that one is guilty if they either unworthily eat or drink. Also, notice the use of the word cup, a common term, which replaces the word chalice. A cup is used for a meal, or for a drink of coffee, or a cup of soup. A chalice is used for a religious sacrifice. A chalice is a gold vessel, inside and out, offering the best available material for its sacred sacrificial contents, for this chalice will hold the very blood of our Divine Savior. The term cup will appear in later heretical translations in the 1960s and 1970s. The term is used by those who detest the thought of sacrifice. The word cup appropriately conveys the sense of a memorial meal, not a sacrifice.

In the Catholic Douay Bible, in the Gospel of Saint Luke: chapter 2, verse 14, we find the well known verse quoted during the Christmas season:

“Glory to God in the highest; and on earth peace to men of good will.”

The King James Version reads:

“Glory to God in the highest, and on earth peace, good will toward men.”

The true meaning of the verse is that we are to give glory to God. God will shower upon his faithful servants His Grace and His Peace. This Peace is a spiritual Peace, which is enjoyed by those who are in the state of Sanctifying Grace, free from the terror and horror of sin. Those who have GOOD WILL are those who strive in every thought, word, deed and action to observe the Will of God, and who never deliberately break any of the commandments of God or of His Church. The perverted translation found in the King James Version leads one to believe that God offers good will to all men, that God somehow must negotiate terms with men and make allowances for their misguided behavior. It sounds as if God is making a peace offering to men, which leads one to believe that this peace is the peace that the world offers, that is, peace from war and violence.

Errors continued, one at a time over 80 years, which produced the de-Catholicization and the Protestantizing of England. The same was true of Germany and other countries. Pandora's box was now opened. Satan was partially unchained. Many others followed with their new theories and newly formed religions. As one error led to another, these reformers claimed to correct what they called the errors of the Catholic Church, thus implying that the promise of Christ to His Church had failed. Using reform as their reason or excuse, they actually created abuses and introduced serious theological errors among the once faithful people who followed them.

The Council of Trent was convened in 1545 A.D., and deliberated for the next 18 years to correct the errors which were rapidly advancing throughout the world. The council promulgated certain and absolute rules pertaining to the Holy Sacrifice of the Mass, as well as the teachings in seminaries and the responsibilities of pastors with regard to the protection of the Faith of the souls charged to their care. It also treated of the proper interpretation of the Bible as this was taught by the Church for centuries and in compliance with the interpretation of the theological Fathers of the Church.

The council mobilized the Catholic counter-reformation to offset the protestant revolt. Saint Robert Bellarmine (my son's patron saint), Saint Charles Borromeo, and Pope Saint Pius V (Antonio-Michele Ghislieri, 1566-1572) were some saintly heroes provided by God at that time to protect the Bride of Christ, His Church. Every action of the new heretics was specifically singled out as to the errors involved, and each was formally and officially condemned with specific decrees binding in law. The Council of Trent was a dogmatic and infallible council of the Church, empowered by God to make these decrees binding on the entire Church for all time to come. Christ said, "Who hears you, hears me." We are to listen to no other.

The inroads of the master deceivers, the enemies of the Church (agents of Satan), continued in the culmination of the Masonic Revolution in America in 1776, a rebellion against the king and monarchy of England in favor of democracy (Democracy, from the Greek, Demo = people, and kratos = power. Therefore:

people power). George Washington, Benjamin Franklin, Paul Revere, Marquis de Lafayette, and many others involved in the American Revolution and our Founding Fathers were high ranking Masons, and are listed in the official Masonic Manual.) The Masonic American Revolution was merely a trial revolution in preparation for the major coup planned for France thirteen years later. Thirteen is a key number for Masons. This Masonic French Revolution was launched in 1789 against the Catholic Monarch and against the Catholic Church of France. The rebels murdered the Catholic King, Louis XVI and his Queen, Marie Antoinette. Rank and file members of Masonry are prevented from knowing the true objectives and intent of Masonry. They are the base of the pyramid which produces the monetary income necessary to support the entire organization. They also need to be thoroughly indoctrinated before they are gradually enlightened as to the true intricacies of the Masonic system, until they are invited into upper echelon positions, they remain pawns of the top leaders. Top, fully enlightened inner circle Masons, however, despise the very idea of Kings, Queens and monarchies, and, of course, the Church, and God Himself. They are devoted to the Supreme Grand Master, the Father of Lies, Lucifer, the archenemy of the Church. Masonry, dating from the establishment of the Grand Lodge of England in 1717 states its objective in the "Bulletin du Grand Orient de France", pages 236-250, issued in 1877. Its first article states "Freemasonry, an essentially philanthropic, philosophic (naturalist) and progressive (liberal) institution, has for its object the search after truth, the study of universal morality, of the sciences and arts and the practice of beneficence. It has for its principles, absolute liberty of conscience and human solidarity. It excludes none on account of his belief. Its motto is "Liberty, Equality, Fraternity". Coexistence is a key objective. Ambiguity in its presentation is its trademark. Masonry is an art or craft, in which its initiates, considered "Light Bearers" (Lucifer?, Thousand Points of Light?), who are encouraged to avoid discussing the controversies of politics and religion. Its ceremonies, together with the entire tone of its doctrine, are based on all religions, embroidering all of its precepts with pagan, Hebrew, and Christian terminology. For example, "I vow to consider myself henceforward and forever as the apostle of truth and of the rights of man." Its system calls for "Fighting for the natural rights of man against religious and political despotism, symbolized by the Papal Tiara and the Royal Crown." Situation ethics is a key rule. The "truth" is whatever it needs to be for the occasion. To say one thing and do another is a common trait. "The Grand Orient of Italy has also the objective to be the standard bearer of Freemasonry in the secular struggle of Masonic light and freedom against the powers of "spiritual darkness and bondage", alluding to the papacy, and dreams of the establishment of a new and universal republican empire with a Masonic Rome, supplanting the papal and Caesarean as Metropolis." The foregoing is directly quoted from the "Catholic Encyclopedia", 1910, article on Masonry.

In March, 1791, Pope Pius VI (Giovanni Braschi, 1775-1799) promulgated his Apostolic Letter warning against and condemning the dangers presented by the action of the new French Masonic National Assembly. This assembly was passing civil laws which intended to place control of the Church into the hands of the laity

and the designated sympathetic clergy. These laws literally stole ecclesiastical properties and placed them in civil hands. The laws encouraged the use of the vernacular (French instead of Latin), the expulsion of nuns from convents and monks from monasteries, and the abandonment of religious vows and the clerical habit. Ecclesiastics were to give their allegiance to civil authority and no longer to the pope. Attendance of the laity at these usurped properties of the Church constituted cooperation in the theft. Contribution to the churches and clergy under their control constituted support of the enemies of God. Pope Leo XIII (Gioacchino Pecci, 1878-1903), in his encyclicals “Humanum Genus” on Freemasonry in 1884, and “Au Milieu des Sollicitudes” on the Church and state in France in 1892 warned of the horror presented to the Church by the secret societies and their objective of overthrowing the Catholic Church. Catholics were then (and still are) forbidden to join Masonic lodges. Eight popes, beginning with Pope Clement XII (Lorenzo Corsini, 1730-1740) on April 28, 1738 (“Ineminenti”) through Pope Pius XI (Achille Ratti, 1922-1939), condemned Masonry for what it is. Anyone who joins the sect is automatically excommunicated by the Church.

Realizing the terrible threat of this increasing activity of the Devil and the destructive influence it intended and presented, both inside and outside of the Church, Pope Leo XIII recommended increased prayers by the Faithful against this most deceptive enemy. In 1896, he published the prayer of Saint Michael the Archangel, which he composed. He recommended that the Faithful throughout the world say this prayer and others, following each Low Mass for this intention. Following the October, 1917 Masonic Communist takeover in Russia, these prayers were also invoked for the conversion of Russia. This was the practice of the Church for 70 years until it was eliminated following the so-called Vatican II council. Pope Leo XIII exhorted priests and even faithful laymen to say the Exorcism Prayer against Satan and the Rebellious Angels whenever action of the Devil is suspected, causing malice in men. These exhortations of the popes are termed paranoid by the enemies of the Church against and for whom the very prayers are directed. Pope Leo XIII also formally condemned Anglican orders (ordinations and consecrations of the Church of England) as illicit (unholy and illegal) and invalid (not real, non-existent), stating that the Church of England and its American counterpart, the Episcopalians, have no valid bishops, priests or sacraments due to irregularity of form, matter and intention. There was not even a doubt that other non-Catholic sects held any claim to licit or valid orders. Therefore no proclamation was necessary for them. Non-Catholic “churches” do not possess Apostolic Succession, nor the Guidance or Blessing of the Holy Ghost. They have no authority from Christ to “preach”. Pope Saint Pius X (Giuseppe Sarto, 1903-1914) again warned of the attack in 1907, in his encyclicals, “Pascendi” and “Lamentabili”, on the heresy of Modernism, that inroads were threatening the very pillars of the Church and that the Anti-Christ was now living among us. He pointed out that the enemies of the Church had already infiltrated seminaries, the very seedbeds and nurseries for the cultivating of young priests, and that these enemies were in fact holding important professorship positions and beginning to teach their deceitful errors. Cardinal Mariano Rampolla Del

Tindaro, who was almost successful in taking the Papal Throne from Pope Saint Pius X, was later discovered to be a Mason. The Irish have long called this heretical sect “The Hidden Hand”, for they have understood that wherever evil is plotted, there, in the background, will this sect of Masonry be actively operating, and planting its destructive seeds.

Pope Pius XI issued his encyclical “Divini Redemptoris” in 1937, in which he warned of the deceptions of Masonic Atheistic Communism. He specifically warned against the danger of its objective to infiltrate religious organizations and to use religion in the indoctrination process of its theories; that it embroiders its ideology into religion and religion into its ideology. He warned of its objective to destroy families and family unity by encouraging women to enter the workforce, thus distracting women from their primary role in the family. All of the decrees, encyclicals and pronouncements of the popes were consistent. They were clear and to the point. They stated the Catholic position and the dangers of errors and condemned them at once. There was no room for any ambiguity or any suggestion of coexistence with error.

Pope Pius XII (Eugenio Pacelli, 1939-1958) was surrounded by a liberal heretical-minded staff in the early 1940s. These individuals had made their way into influential top Vatican positions in the Church. Roncalli (later “John XXIII”), Montini (later “Paul VI”), Bugnini, Bea, and Suenens, all of whom were Cardinals, are some, to mention only five of the most influential culprits. Ambiguity began to appear in Church documents. Changes began. In 1948, prayers concerning the conversion of the Jews were removed from the Holy Week Liturgy. In 1948, the requirement for handing over the instruments in the ordination ceremony was removed. In 1956, the words of consecration in the Holy Week Liturgy were altered, changing the meaning, even though the Council of Trent had specifically forbidden any changes which changed the essential meaning in the Canon of the Mass. In 1957, the Communion Fast was changed from the previous Midnight to three hours prior to the reception of Communion. The Church has all right and authority to change its earthly laws, laws pertaining to Discipline. It does not have the authority to change Divine Law or to enact laws which contradict Doctrine or its long established Tradition. These changes represented both a weakening of the Church’s discipline and a departure from Tradition and practice. They also make one wonder why this was happening, and who was responsible for these injurious changes and who was really in charge. This was a tare planted to weaken the vine, as would be realized in a few short years. The groundwork had been clearly established for the final stab to the heart. Pope Pius XII died October 9, 1958, under a cloud of suspicious circumstances: his death certificate gives the cause of death as “Poison”. May God have mercy on his soul!

This and the poisoned deaths of Pope Pius XI and “John XXIII”, were reported in the personal papers of Eugene Cardinal Tisserant (created Cardinal in 1936 by Pope Pius XI). He, a Cardinal Bishop, held the highest seniority of Cardinal Bishops and the highest seniority of all Cardinals. He was the Dean of the Sacred

College of Cardinals. He was known as a “Distinguished scholar and eminent churchman, expert in the liturgical arts of the Eastern Rites, world authority on the Oriental languages, master of manuscripts”. He was the Librarian and Archivist of the Holy Roman Church. He spent more than 40 years in the Vatican. If anyone would know the internal operations of the Vatican, he certainly would. Cardinal Tisserant was a dissenting voter (against the “reforms”) at the “Vatican II Council” and suspecting the adversaries, made certain that his private papers did not fall into their hands, but made arrangements for his papers to be removed from his Vatican office and placed into the hands of his niece. When he died, his casket was placed on the floor, rather than on the usual catafalque (a decorated platform or framework on which a coffin rests in state during a funeral ceremony): treatment deserving of a “dog”. This is how the “adversaries” expressed their hatred of one who opposed them, a once-highest prince of the Church. No one knows when he discovered the poison information or what he planned to do about it. If one of the “adversaries” had discovered that he possessed the information, who knows how he really died? May God have mercy on his soul! Why did they treat his remains with contempt at his funeral? It seems that somebody knew something!

“John XXIII” (Roncalli, also known as “Papa John”) was selected, October 28, 1958. He decided to choose the name of the heretical anti-pope, John XXIII (the last of the Western Schism, 1410-1415, deposed by the general Council of Constance in 1414). This was a clear break with the Tradition of the Church, which never gives honor to heretics. There is no surprise for his actions, for he had been a Mason since 1935, and ipso facto excommunicated for such membership. This Angelo Giuseppe Roncalli is the same Roncalli, who, during World War II, in his Vatican administrative position, was responsible for giving honor to thousands of infidels. He administered the program to place forged documents which claimed that thousands of Jews were Catholics and not Jews. These documents were falsified Baptismal certificates. This was in the newspapers and on television, once the controversial action was discovered. These were Jews in Nazi Germany who were to be saved from Hitler. Lies, underhandedness and deception were his methods of operation. Surprised? Within two months of his selection, he claimed that through the inspiration of the Holy Ghost, he would “call a council”. He knew this was already the Masonic plan for years. He named this the “Vatican Council II” which got under way on Saturday, October 13, 1962. The number 13 is a magical Masonic symbol and is used as a general signal to the rest of Masonry throughout the world. “John Paul II” was shot on May 13! I have in my possession four hard bound 288-398 page volumes, published in 1963-64-65 and 66, written by heretical priests-reporters, using the pen name of Xavier Rynne, who attended the council. These books describe the preparatory procedures and the revolution which occurred during the “Pastoral Council” in which the Masonic objectives were finally insinuated into the worldwide Church organization. In these books, they gleefully cheer every step the “council” took which led the Church organization gradually away from the actual fold of the true Church. In 1962, “John XXIII” inserted the name of Saint Joseph into the Canon of the Mass, a seemingly innocent insertion. The

Council of Trent had specifically stated that no additions were permitted in the Canon of the Mass. The Church had for centuries before and after the Council of Trent not included the name of Saint Joseph in the Canon of the Mass. This insertion of the name of Saint Joseph by “John XXIII” was a deliberate defiant test and one of many steps of progressive gradualism to come.

Remembering Roncalli’s handling of the Jewish “Baptismal Certificates”, it should come as no surprise that he was in fact, already an active enemy of the Church doing his dirty work on the inside. An Italian news agency reports that Vatican sources have confirmed the existence and authenticity of the following false “prayer” composed by Roncalli just before his death. It was printed in the Jewish B’nai B’rith Messenger, November 4, 1964 as follows:

“We realize today how blind we have been throughout the centuries and how we did not appreciate the beauty of the chosen people nor the features of our favored brothers. We are cognizant of the Divine mark of Cain placed upon our forehead. In the curse of centuries our brother, Abel, has been lying bleeding and in tears on the ground through our fault, only because we had forgotten Thy love. Forgive us our unjustified condemnation of the Jews. Forgive us that, by crucifying them, we have crucified You for the second time. Forgive us. We did not know what we were doing.”

This is nearly a deathbed testimonial of a person who was NOT a Catholic, NOT a pope, but the usurper of the papal throne, who, with his adversarial comrades, planned the complete destruction of the organizational Church. His quote “prayer” is not a prayer, but a blasphemous, slanderous lie against the Pure Bride of Christ, the Holy Catholic Church, which has always been and will always be protected by the Holy Ghost from preaching error. Roncalli, having achieved the objectives planned for him, peacefully died as a thief who had achieved honor among thieves, poisoned by those who placed him on the throne. He had achieved all that they wanted him to do and now it was time for the next criminal usurper to open his bag of dirty tricks. “John XXIII” (Roncalli) died during the “council” on June 3, 1963. May God have mercy on his soul! “Paul VI” continued the work of “John XXIII”, and the “council” concluded on December 8, 1965. According to the law of the Church, a council dies with the death of a pope. A new council must then be convened if the work is unfinished. But, of course, this did not occur. According to their renegade procedure, “Paul VI” simply continued the so-called “Vatican Council II”.

The official sixteen documents of “Vatican Council II” were published for the perusal of the world in 1966. The documents appear to be Catholic, employing Catholic phraseology throughout, supported by scriptural quotations and previous Church writings. One can also read Anglican documents which appear very “Catholic”, but with proper vigilance, one will discover the non-Catholic errors and heresies woven into the “Catholic” embroidery. This deceptive Catholic embroidery technique appears throughout the presentation of the sixteen Vatican II documents. Select scripture quotations and previous Catholic

writings are misused to support the introduction of errors. Constant misinterpretation of each is employed to support new theories. Each of the sixteen documents introduces specific heresies or departures from Catholic Tradition.

The opening statement of the document's "message to humanity" sets the trend and the intention of the entire council. The social objective is ".....to achieve a way of life worthy of human beings (we would emphasize whatever concerns the dignity of man, whatever contributes to a genuine "community of peoples" -page 5) The mission of the true Catholic Church is to save souls. The mission to "make the world a better place to live", to achieve "human dignity" and a "community of peoples" are the objectives of Masonry, Liberalism, Modernism, False Humanism, Rationalism, Socialism and Atheistic Communism. Atheistic Communism is the epitome of masterful deceit and is the world-class expert organization which uses religion to ensnare populations into its ideology. On page 6, the "message of humanity" gives honor to those outside the Church by referring to them as "brother Christians and the rest of men "of good will". Christ told his apostles "Going therefore, teach ye all nations; baptizing them in the name of the Father, and of the Son, and of the Holy Ghost, teaching them whatsoever I have commanded you (Saint Matthew, chapter 28, verses 19 and 20). "He that believeth and is baptized shall be saved: but he that believeth not shall be condemned." (Saint Mark, chapter 16, verse 16) The Catholic Church and the Catholic Church alone embraces the complete teaching of Christ, the Deposit of Faith. To believe in Christ, one must follow His Church and ALL of its teachings. To simply believe that Christ existed, that He was a good Man, that He was a prophet, that He was the Son of God, that he died on the cross for our sins, or any other segmented precept of Christianity, but to reject some or any of His teachings and those of His Church does not make one a Christian. Satan himself believes in Christ, but he is the number one enemy of Christ and His Church. Satan is certainly not a Christian, even though he knows and understands each and every principle of Christianity.

We may say that we believe that Karl Marx lived, died and preached Communism. We may have studied his Communist Manifesto. We may even agree with some of his principles with regard to the responsibilities of the individual in relation to the benefit and betterment of the community. However, that does not make us atheistic Communists. We deliberately reject his atheistic principles, and his theories of Socialism. We are not atheistic Communists.

Similarly, those outside the Catholic Church, first of all, reject the Church founded by Christ, they reject one, many or all of the teachings of Christ. They accept divorce and remarriage; they believe in birth control: they believe in abortion; they believe that only the Bible constitutes the teaching of Christianity and then decide for themselves what it means and reject Tradition and the Oral Teaching of Christ and the Apostles; they reject some or all of the Sacraments and the Holy Sacrifice of the Mass; they reject some or all that Christ commanded the Apostles to teach. They are NOT Christian. Christ, Himself, said they are to be

condemned, not honored for their rejection of His teachings and those of His Church. They promote a teaching different from that taught by Christ. In so doing, they exercise their free will to accept or reject the Truth. Their will to reject the Truth does not constitute GOOD WILL, but self-will, subject to merely good or bad intentions which lead them into error in the first place and keep them there. It does not matter what they want to call themselves, or what they call their buildings. They are not part of the Church founded by Christ. They are devoted followers of false teachers, false preachers, and false prophets, not followers of Christ. They follow those who have no authority to teach or preach, those who were not sent by Christ. They are outside of the Church and we pray for their return to the True Fold of the One True Shepherd. True Catholics do not give them esteem and honor them by calling them BROTHER CHRISTIANS.

With regard to the “Declaration on the Relation of the Church to non-Christian Religions’, just following the praising of Hinduism and Buddhism for their “positive qualities”, item #3 begins: “Upon the Moslems, too, the Church looks with esteem, .” The true Church specifically teaches that we cannot give esteem, which means honor, high regard, and praise, to infidels and others outside of the Church, but She does teach that we should direct our compassion, sorrow, pity, kindness, Charity and fraternal correction toward them. The very fact that those outside the Church are out side the Church is because they have accepted error mixed with bits of truth and have fallen into this age-old deceptive entanglement of Satan which has successfully caused millions to perish. We do NOT look to their sorrowful condition WITH ESTEEM. Moslems (Muslims, followers of Islam) believe that each male will receive 72 maidens as their reward in their heaven for their service to their Allah on earth. No wonder their hordes of men cling to their beliefs. Evidently, the poor women receive only one man and share him with 71 other women. What a religion!

With regard to the “Declaration on Religious Liberty” (or freedom), item #11, paragraph 6 states:

“In the end, when he completed on the cross the work of redemption whereby he achieved salvation and true freedom for men, he also brought His revelation to completion.”

Whoops! Here, they proclaim one theory in support of non-Catholic teaching- “achieved salvation...for men”-, deny three tenets of the Catholic Faith and deny the very foundation of most non-Catholic religions, The New Testament.

The Holy Ghost permits them to betray themselves, revealing the very lack of His Guidance in the entire “council”. What they have written is outright, very clearly stated HERESY. The Catholic Church teaches that the Death of Christ on the Cross was His Perfect act of Redemption for all mankind. The act of Redemption opened the Gates of Heaven, previously closed. This Sacrifice on the Cross redeemed mankind so that the individual may be able to enter through the Gates of Heaven, and provided the means to enter Heaven for all eternity, the means to

achieve salvation. Christ provided the means to achieve salvation by giving us His Holy Catholic Church and the Guidance of the Holy Ghost cherished within it. We are to achieve our own salvation by following in His Footsteps, by belonging to His Church and by following the teachings of His Church, and no other. If we do so faithfully and die in the state of Sanctifying Grace, then and only then do we achieve salvation. Yes, no other church claiming to be Christian or otherwise, qualifies, and will not lead us to Heaven, but simply in the opposite direction. Protestant theology proclaims that Christ, in taking the burden of our sins on His shoulders, covers them up and that by Faith alone, or by the act of believing, man is saved. They ask, "Brother, do you want to be saved today?" "No, thank you!" (my husband said when he was asked the question in the Army..!!) Catholics believe that by the Grace of God, by our good works, contrition for our sins, penance, atonement and constant adherence to the teachings of the Catholic Church, we will be saved the day we die, and not one day before. "He who perseveres to the end will be saved." (Saint Matthew, chapter 10, verse 22)

The next problem in this "council" statement is "...He also brought His revelation to completion (or perfection) on the cross." Christ did not bring His Revelation to completion or to perfection on the cross. This statement could very well have been written by one of the Pharisees. They had Christ put to Death by the Romans because their own law forbade them to do it themselves. Their law and Roman law permitted them to stone to death blasphemers. They wanted Christ to suffer the humiliation, the public shame and the slow ignominious pain of the crucifixion which was the common Roman execution reserved for public criminals. They wanted to sacrifice one man for the sake of the nation and to accomplish this before the Feast of the Passover would begin. Whatever "this Christ" was saying (revealing) would end with his death on the cross. They thought they could kill Truth and bury it, once and for all. To them, that would be the final and perfect solution, which would satisfy their hatred and injured pride. This declaration of the Document denies the Revelation of the Resurrection, the greatest event of Christianity, the crowning Glory and proof of everything Christ said and did after His Resurrection until His Ascension into Heaven. It denies the Mission of the Church which He gave to the Apostles and Disciples. It denies the establishment of the Sacrament of Penance. It denies the Promise of Christ to send the Holy Ghost, the Inspiration of the Church. It denies the institution of the Sacrament of Confirmation. Following the Ascension, it denies the Descent of the Holy Ghost and all Revelation contained in the entire New Testament to the very last word, the "Amen", of the Apocalypse. It denies that the Apostles and Disciples, and the Evangelists were inspired by Revelation to write the words that they wrote. The other problem is that this statement would not sit very well with most non-Catholics they are trying their best to please in everything else, since Protestants base ALL on their (perverted) versions of The New Testament. How could any such blunder appear in an official Catholic document? The answer is stunningly simple: This document obviously was not written by Catholics. The remaining 700+ pages of the documents continue to introduce similar misleading statements and errors. The

key objective is coexistence with other false religions, to establish "...meetings between the two sides, especially for discussion of theological problems, where each can deal with the other on an equal footing." (Declaration on Ecumenism, item #9) "Through such dialogue, everyone gains a truer knowledge and more just appreciation of the teaching and religious life of both communions." (Document on Ecumenism, item #4, second paragraph)

This equal footing theory is expressly condemned by Pope Pius XI in his encyclical, "Mortalium Animos", on the promotion of true religious unity, 1928, and by many other popes. The trademark of the "Vatican II" documents is ambiguity and contradiction. A truth is stated, and then is perversely contradicted. This technique of introducing falsehood is a common tool used throughout history to sway generations from truth and sanity to error and insanity. The truth is mentioned, then, the falsehood, the exact antithesis, is introduced. Thereafter, the true statement is not mentioned and the antithesis becomes the new "truth". This is a clear example of situation ethics. What is the truth today, sir?

The teaching of the True Church with regard to the inspiration of the Holy Ghost is regularly perverted to support the theory of the council on false ecumenism. The "Dogmatic Constitution of the Church", Item 15, paragraphs 1 and 2, states concerning those outside of the Church who profess to be "Christian": "They are consecrated by Baptism, through which they are united with Christ. They also recognize and receive other sacraments within their own churches or ecclesial communities. Many of them join in the episcopate, celebrate the Holy Eucharist, and cultivate devotion toward the Virgin Mother of God. They also share with us in prayer and other spiritual benefits." "Likewise, we can say that in some real way they are joined with us in the Holy Spirit, to them also He gives His gifts and Graces, and is therefore operative among them with His Sanctifying Power. Some indeed he has strengthened to the extent of the shedding of their blood." Wow! Saint Augustine disagrees that this "shedding of blood" has anything to do with their being strengthened by the Holy Ghost. In his sermon, "Contra Donat", he says:

"For some there are among the heretics, who, because of their evil doings and their errors, have suffered some vexations, flatter themselves with claims of martyrdom, so that whitewashed, as it were by this, they more readily plunder: for they are wolves. But not all who submit their bodies to suffering, even to the flames, are to be held as having shed their blood for their sheep; rather they may have shed it against the salvation of their sheep, for as the Apostle says: 'If I should deliver my body to be burned, and have not charity, it profiteth me nothing.' (First Epistle of Saint Paul to the Corinthians, chapter 13, verse 3) And how can he have the faintest charity in him who, though shown to be at fault, has yet no love for that unity commending which the Lord chose to speak, not of many shepherds, but of one; saying, 'I am the Good Shepherd' ."

The second paragraph of the same “Dogmatic Constitution of the Church” document states “By Her relationship with Christ, the Church is a kind of sacrament or sign of intimate union with God, and of the unity of all mankind.” Then in item #8, paragraph three, the same “Dogmatic document” states “Just as Jesus carried out the work of redemption in poverty and under oppression, so the Church is called to follow the same path in communicating to men the fruits of salvation.” This sentence is qualified by footnote #25: “Unlike Christ, the Church is not a Divine Person; in its concrete historical essence, it is capable of being tarnished by sin.” Now, let’s figure this out. What exactly was said? They said that the Holy Ghost sanctifies false religions. This “church is a kind of a sacrament” which is capable of committing sin! This among many other apologies for the previous “wrongs” of the Church deliberately slanders the Pure Bride of Christ, a Divine infallible institution, guided by the Holy Ghost, as being guilty of sin. Does the Holy Ghost commit sin? Apparently, they say so. This council statement is insane and is obvious heresy, and obviously was not written by Catholics.

The Church teaches that individual people: men, women, children, whether they be popes, cardinals, bishops, priests, hermits, nuns, monks, husbands, wives, fathers, mothers, brothers, sisters, sons or daughters are capable of committing sin. They are members of the Church. The individual is capable of sin, not the Church. One single error, one single false pronouncement of heresy, is sufficient to cast the entire “council” and ALL who willfully follow it outside of the Fold of the Catholic Church, just as happened in England and Germany in the 1500s. The ‘council” documents proceed, however, to pronounce several errors and heresies. The issues raised and the trends which are followed, betray the intention to de-Catholicize the Church organization and make it pleasing to Protestants and all of those outside the Church. The ‘council” proclaiming itself a “Pastoral Council” (one that pastors the flock) as opposed to a Dogmatic Council (one that defines doctrine, formulates decrees and legislates for the entire Church), pretends to formulate “Dogmatic Proclamations and Constitutions”, counting on the fact that most of the rank and file will not know the difference, changes nearly everything, and operates in direct opposition to the Decrees of previous Dogmatic Councils and the centuries-old Tradition of the true Catholic Church, all of this without any legal or official abrogation (according to the strict law and Tradition of the Church). A complete book of commentary would be necessary to expose each and every issue. One note: Purgatory and Hell are never mentioned throughout the entire documents. Why not? (Pastoral Council? Dogmatic Decrees?)

The “council” now convened (December 8, 1965), began to launch its plan of renewal, meaning a complete change into something else. The planned process will involve patient and progressive gradualism. A valuable feature of this technique of gradualism is that, at each new step a certain precedent is established, one which at a later time can be referred to as a support for the more advanced changes. All prayers of the Mass will change and the thinking of all Catholics who continue to be indoctrinated will change accordingly. *Lex orandi, lex credendi*, the

law of praying is the law of believing is an old theological axiom. Change the manner of praying and the manner of believing will automatically follow. As time marches on, the enemies of the Church march on with their well-calculated plan of confusion. Who knows what will happen next? They certainly do. It has been their plan for many, many years.

Under the direction of “Paul VI”, changes came by the boatload. In his own book, Paul VI Dialogues, Reflection on God and Man, his hand picked biographer quotes him as saying: “Sin is an offense against man, before it is an offense against God.” (page 32)(This is the heresy of Humanism!). The Church has always taught that sin is an offense against God, then against our neighbor. This was one indication of how he would reverse everything he possibly could that the true Church has ever taught or practiced. He introduced the “Novus Ordo Missae”, his new order of the “mass”, said in the native tongue (the vernacular). (The new order of the world is a key objective of Masonry. A new world order or a new order is how we hear it spoken today. Look at a one dollar bill and note on the back, underneath the pyramid, and the Seeing Eye, the words “Novus Ordo Seclorum”, meaning “The New Order of the World”. These are all symbols of Masonry, including the Seeing Eye and the triangle of the pyramid. This was introduced to the dollar bill in 1935 by the Masonic Socialist President Franklin Delano Roosevelt.) Remember Cranmer’s Book of Common Prayer? This “Paul VI” new “mass” was developed with the help of six (6) Protestant ministers, who were invited to the “council”. Not surprisingly, the service is almost a carbon copy of the non-Catholic Anglican service introduced in England in 1540 by King Henry VIII with the help of his number one man, Archbishop Cranmer. The main difference is that, ironically, the English service of 1540 used the words “For you and for many” commemorating the words of Christ at the Last Supper. We viewed on television this past Christmas the Episcopalian service in the Washington, D.C. Cathedral. It was remarkable to see the striking similarities in the service to the “New order of the mass”. The “new order of the mass” service now used in once Catholic churches is nearly a carbon copy of the Episcopalian service. The Paul VI version eliminated the words of Christ by using “For you and for all men”. Yes, beware. This new “mass” service is a Protestant service and is not pleasing to God.

Later, under “John Paul II”, they dropped the “men” at the behest of women’s lib and replaced it with “for you and for all”. They also obeyed the behest of women’s lib by allowing women to remove the required chapel veils from their heads while in church and by allowing them to speak in churches. This obedience to women’s lib is in defiance and in direct opposition to the command of the Apostle Saint Paul, “But every woman praying or prophesying with her head not covered, disgraceth her head: for it is all one as if she were shaven. For if a woman be not covered, let her be shorn. But if it be a shame to a woman to be shorn or made bald, let her cover her head. The man indeed ought not to cover his head, because his is the image and glory of God: but the woman is the glory of the man. For the man is not of the woman, but the woman of the man. For the man was not created for the woman, but the woman for the man. Therefore ought the woman to have a power over her head.”(First Epistle of Saint Paul to the Corinthians, chapter 11,

verses 5-10) and “Let women keep silence in the churches; for it is not permitted them to speak,, but to be subject, as also the law saith, but if they would learn anything, let them ask their husbands at home. For it is a shame for women to speak in the church.” (First Epistle of Saint Paul to the Corinthians, chapter 14, verses 34 and 35). Obviously, Saint Paul is not a favorite of Women’s libbers. The modern conditioning of the followers of the new sect (still called the “Catholic Church”) is so complete, that their theologians and professors regard Saint Paul as one who had a problem, saying that he was a chauvinist, that he did not have respect for women. He was the one chosen by God to be the Apostle of the Gentiles. He (then named Saul) was the one whom God chose to strike from his horse as he was pursuing the persecution of Christians. Do they think that God make a mistake in choosing Saint Paul who was inspired by the Holy Ghost to say what he said, and who was personally commissioned by Christ Himself? What unfathomable pride is exhibited in showing disdain for any of the saints of God, especially the Great Apostle, Saint Paul. What arrogant pride these deceptive heretics of this new false religion possess!

These actions of renewal are not renewal, but acts of updating, (the Heresy of Modernism) modernizing to be in line with the modern thinking of women’s liberation, a 1960s rebellion, which is a denial of the teaching of The New Testament. Those who follow the teachings of these new rebels are the ones who have the real, very serious problem, for they are ensnared in Satan’s trap. New “prayers and petitions” which are more in line with the new theology replaced the centuries-old doctrinal prayers, thirty-five (35) of them, including two in honor of the Blessed Trinity and one in honor of the Holy Ghost, the Sanctifier. Altars were destroyed, or removed, priests turned their backs on whatever altars remained and faced the people to recite their new protestant service. (The Heresy of Humanism) Tables replaced altars, the interiors of “churches” were arranged in a manner identical to the arrangement found in Masonic Temples (as can be seen in actual official Masonic handbooks). Statues and pious devotions were eliminated. Buildings were modernized, old ones were destroyed or abandoned by the thousands across the world. The “priesthood” of the laity made its entry along with laymen and women parading around the former sanctuaries handling vessels and “communion” (This is typical Presbyterianism!). Grape juice for use in the service was approved as an exception for the “problem priest” versus the required “properly fermented wine”. Wheaten bread and pure wine are the two absolutely essential elements for valid and licit consecration: vegetable oil was authorized versus pure olive oil and ordinary candle wax was authorized versus 50 %+ beeswax, stating that the former items are now considered too expensive. The true Church has always required the most pure elements in its sacrifice and ceremonies to honor Almighty God. The Grace of God is the solution for any priest having a problem consuming wine. With the Grace of God now removed, many problems have entered in. Sacraments were all changed in defiance of the Church’s requirements for valid matter, form and intention. Traditional hymns were mostly eliminated. Gregorian Chant was suppressed while they said it was to be “given pride of place” (the trash can?) and modern songs were introduced, spontaneous “prayer” was introduced to fit the ever-changing situation. People were taught to

sit and stand instead of kneeling (at “communion”) or genuflect. The Bible was rewritten to update it and to make it fit the new thinking and new theology. We were always taught to show proper respect due while praying. To kneel erectly with hands folded pointing heavenwards. Now, observing the members of the new sect, one can clearly see that there is no respect, no posture required, no reverence. Any position is accepted. The stated objective to destroy piety has been achieved. Bowing the head at the mention of the Name of Jesus is out of date. The accepted posture, if any, is to stand with hands folded below the waist, head bowed in true ecumenical, protestant style. If you are going to be a good protestant, you might as well act like one. Why not? Everything is done to please man and to convince everyone that the new “catholic” is a new ecumenist (protestant). Even the Our Father has been changed to the long-rejected non-Catholic version, ending with “For yours is the Kingdom and the Power and the Glory, now and forever”. Why add this phrase? Our Lord did not teach His Apostles these words. It was long ago proved that these words were merely marginal notes of some pious person transcribing the words of scripture into the vernacular. The Church deliberately decided not to use them in its liturgy, or as an official part of the Our Father. Why are they added now? They have long been used by protestant sects to end the Our Father. So, if you are going to be a protestant, calling yourself a “catholic”, why not act like and imitate Protestants? Unfortunately, there is no acting and no imitating. Participants in this new religion are protestants.

Sunday obligation, not yet eliminated, was changed to a “weekend” obligation. For convenience, one may now attend “Sunday mass” on Saturday which takes care of the “Sunday” obligation. Saturday is the Sabbath for Jews and Seventh Day Adventists. Sunday is the Sabbath for Christians (Catholics). Why are they straddling the fence? Now which day is the Sabbath for the “new church” and why? Why Saturday? This is one of those steps of patient gradualism which makes the necessary preparation for the next step, no obligation at all, or perhaps Saturday Sabbath, or both? Non-Catholics have had no obligation to do anything for more than 400 years. Are there more important things to do on Sunday, such as working, shopping, watching TV, going to the movies, washing the car, or going to the casino. We see busloads of Knights of Columbus folks heading for the casinos every Sunday. Hey, nice church outing, eh? They now say that observance of Sunday begins about 4:00 P.M. on Saturday. In the Seminary, we gathered in chapel at this time to say vigil prayers, “Vespers”, in preparation for Sunday. We were taught that this was preparation and had nothing to do with our Sunday obligation to attend Mass during the specified canonical hours on Sunday. What an illogical reversal this is, among many others. The 1988 Catholic Almanac mentions this subject on page 218, under the heading “Sunday Mass on Saturday”. Does that not sound a bit silly? Sunday Mass on Saturday? Why not Sunday Mass on Tuesday or Wednesday? In the Almanac, they avoid offering any explanation of Saturday being Sunday, but merely state:

“The Congregation for the Clergy, under date of January 10, 1970, granted the request that the faithful, where bishops consider it pastorally necessary or useful, may satisfy the precept of

participating in mass in the late afternoon or evening hours of Saturdays and the days before Holy Days of Obligation.”

It is amazing to realize how the bishops would have been stormed by requests of the “faithful” for “Sunday mass on Saturday”, and they, realizing the “pastoral” necessity and usefulness of this illogical change, granted the exception in every diocese in the United States. It is now common practice in virtually every parish across the country and around the entire world. What deceptive liars they are! It is amazing how they have gradually made protestants out of their unsuspecting and now very duped flock. Can you imagine real Catholics in 1957, knocking on the rectory door for the purpose of asking the pastor to allow them to go to Mass on Saturday, and asking that that would fulfill their Sunday obligation? “Father, can we go to Sunday Mass on Saturday?” Imagine his response. He would have jumped out of his chair and asked from which planet they hailed. Imagine the pastor calling the Chancery Office to request the same from the bishop. “Your Excellency, my parishioners have requested that they be given permission to attend Sunday Mass on Saturday. Will you give us permission to do that here at Saint Christopher’s Parish?” Imagine the reaction of the bishop to this ludicrous request! He would have immediately questioned the competency of this pastor, relieved him of his duties, and assigned him to the nearest Trappist Monastery.

Abstinence, fasting, Ember Days, Rogation Days and any other representations of penance and self-denial or mortification are virtually non-existent in the new sect (stilled erroneously called “catholic”). These “negatives” are considered demeaning to “human dignity” (the Heresy of Humanism). Lent has become a season of the year instead a time of penance. Monastic life was de-emphasized (discouraged). Does any of this sound familiar?

Seminary training was altered even more than it had already been and vocations ceased by the thousands. Priests poured out of the church, while nuns poured out of the convents. Does this sound as if the Guidance of the Holy Ghost is operating here? A relative of mine left the Oblates of Saint Francis de Sales and attempted “marriage” with a still professed nun. In letters back and forth to his superior on the subject (We have the letters!), he received “Kindest Regards” to him and “to your dear wife” from the worldwide head of the order located in Toledo, Ohio. Later, he received from the Vatican the “Blessing” of “Paul VI”, and an official laicization” (changing a priest into a layman, a new thing of the new religion sect, never permitted by the real Catholic Church) after 15 years in the seminary and 11 years as a priest. This allowed him and his already live-in (concubine) intended (the public sin of concubinage, which is an official impediment to marriage) to celebrate “the canonical regulation of their civil marriage” by an official ceremony performed at the Philadelphia Archdiocesan Cathedral Church of Saints Peter and Paul, June 4, 1971. This is another clear example of how the new religion, pretending to be Catholic, really works. Thousands of priests were asked to retire, especially those who did not agree with the new theology. What sense is there in asking priests to retire, when there is a severe shortage of priests? There has to be

a devious reason for this. Seminaries and convents closed and were sold. The seminary I attended, Mother of the Savior Seminary, is now Camden County College. It was sold to Camden County in the late 60s. The Maryknoll seminary where my cousin attended in Clark's Summit, Pa., was sold to the Baptists to become a Baptist seminary. His college seminary in Glen Ellen, Illinois, was sold to a developer. The seminary was torn down, and houses were built. Between 1965, when the "council" plan was launched and 1990, 3 million, 100,000—3.1 million students fewer are attending "Catholic" schools in 1990 than in 1965, a 55% loss of students. One reason given is lack of money (Columbia Magazine, April, 1990). The True Church never had any trouble maintaining and building the growth of its parish schools, even in the darkest days of the Depression. Obviously, the plan of the enemies of the Church of God is being followed and is working according to its design.

These ravaging reformers were to make sure that they would leave no stone unturned in their effort to overturn the Traditions and Doctrines of the Bride of Christ, the Holy Catholic Church. Not to be outdone by previous reforming heretics, they were sure to meddle with Sacred Scripture, and its presentation to the public, so that their new version would support their heretical, de-sanctifying, and humanizing reform. This devilish and devious task was launched in the 1940s with the introduction of the Confraternity edition of the Catholic Douay Bible. This was introduced in 1941 by the Episcopal Committee of the Confraternity of Christian Doctrine. This updating process of re-translation and communizing of Scripture was spearheaded by Cardinal Bea, a Mason, in the late 1940s. The culmination of years of tampering and re-tampering resulted in the United States with the publication of The New American Bible. The 1988 Catholic Almanac, on page 186, explains: "A new translation of the entire Bible, the first ever made directly into English from the original languages under Catholic auspices, was projected in 1944 and completed in the Fall of 1970 with the publication of The New American Bible."

The Episcopal Committee of the Confraternity of Christian Doctrine sponsored the NAB. The translators were members of the Catholic Biblical Association of America and several fellow scholars of other faiths. The typical edition was produced by the Saint Anthony Guild Press, Paterson, New Jersey, U.S.A." It continues on page 187, under the heading New Translation of New Testament: "A new translation of The New Testament (of the New American Bible published in 1970) was made public April 5, 1987, in Washington, under the auspices of the U.S. Catholic Biblical Apostolate. It features gender-inclusive language where appropriate and in accord with the meaning of the original text. (??, What original text, The New American Bible..?? Yes, that is what they mean. By "original text", they mean The New American Bible—comment added) The 1970 New Testament remains the text approved for use in the liturgy." The ugly head of the Beast, Satan, can bear not to reveal itself. Just quoted in the last sentence, the 1988 Catholic Almanac reveals that The New American Bible is "the 1970 New Testament." This is an appropriate term, for the NAB is a rewritten version by the Modernists which fully intends to pervert its reader into a follower of the heresies

of false Humanism, false Ecumenism, Modernism and Liberalism. It is a new New Testament and is titled appropriately, "The 1970 New Testament". Let us look at some examples of this "New Translation", or more appropriately, deliberately calculated mistranslation, as it compares to the Catholic Douay translation of the Latin Vulgate of Saint Jerome.

On page 15 of this letter, we examined two mistranslations found in the King James Version. The first verse examined was that from the First Epistle of Saint Paul to the Corinthians: chapter 11, verse 27. The Catholic Douay Bible reads:

Therefore whosoever shall eat this bread, or drink the Chalice of the Lord unworthily, shall be guilty of the Body and of the Blood of the Lord."

The King James Version reads:

"Wherefore whosoever shall eat this bread, and drink this cup of the Lord, unworthily, shall be guilty of the Body and Blood of the Lord."

Recall the explanation of the work cup, a common term, which replaces the word chalice. A cup is used for a meal, or for a drink of coffee, or a cup of soup. It could even be a paper, or plastic Dixie Cup used at a picnic. A chalice is used for a religious sacrifice. A chalice is a gold vessel, inside and out, offering the best available material for its sacred sacrificial contents. The term cup will appear in later heretical translations. The term is used by those who detest the thought of sacrifice. The word cup appropriately conveys the sense of a memorial meal, not a sacrifice.

The New American Bible version of 1970 reads, beginning with verse 26 reads:

"Every time, then, you eat this bread and drink this cup, you proclaim the death of the Lord Jesus until he comes." Verse 27: "This means that whoever eats the bread or drinks the cup of the Lord unworthily sins against the Body and Blood of the Lord."

Notice the perverted use of the word cup to replace the original translation of chalice. In order to be consistent, they must, in some way, agree with the heretics who they are trying to please.

The second example which was examined on page 15 of this letter was taken from the Gospel of Saint Luke: chapter 2, verse 14, in which we recall the well known verse quoted during the Christmas season, in the Catholic Douay Bible:

"Glory to God in the highest; and on earth peace to men of good will"

The King James Version reads:

"Glory to God in the highest, and on earth peace, good will toward men."

Recall the explanation given on page 17, with regard to this verse:

The true meaning of the verse is that we are to give glory to God. God will shower upon his faithful servants His Grace and His Peace. This Peace is a spiritual Peace, which is enjoyed by those who are in the state of Sanctifying Grace, free from the terror and horror of sin. Those who have GOOD WILL are those who strive in every thought, word, deed and action to observe the Will of God, and who never deliberately break any of the commandments of God or of His Church. The perverted translation found in the King James Version leads one to believe that God offers good will to all men, that God somehow must negotiate terms with men and make allowances for their misguided behavior. It sounds as if God is making a peace offering to men, which leads one to believe that this peace is the peace that the world offers, that is, peace from war and violence.

Now let us examine The New American Bible version of this verse:

“Glory to God in high Heaven, peace on earth to those on whom his favor rests.”

It is clear that the erroneous translators of The New American Bible have slyly chosen to avoid the difference between The Catholic Douay Bible and the controversy created by the King James Version mistranslation by completely eliminating the use of the term GOOD WILL. This, of course, is not all that they have eliminated as will be seen.

The very first striking difference, which even the casual observer will find obvious, is the elimination of the word Saint at the beginning of each Gospel and at the top of each page in the text:

The Catholic Douay Bible, for example, lists the heading on the first page of the Gospel of Saint Luke:

The Holy Gospel of Jesus Christ,
According to St. Luke
And on top of each page of the Gospel is listed:

St. Luke

The King James Version lists the heading:

The Gospel According to Saint Luke
And on top of each page of the Gospel is listed:

St. Luke

The New American Bible lists the heading:

The Gospel According to Luke

And on top of each page of the Gospel is listed:

Luke

What happened to the title of Saint Luke? Is he now to be known, according to the erroneous translator heretical deceivers as simply Luke? Of course, the same downgrading occurs with Matthew, Mark, John, Peter and Paul. This is all part of the leveling process. They want to bring everyone down to a cozy earthly level so all can be chummy buddies. Father Joseph Murphy will now be known as Joe, or perhaps, Father Joe. The saints and evangelists writers of the Gospel are stripped of their canonized title of saint. How would these heretical erroneous translators of the New American Bible feel if they, as Doctors of Philosophy or Doctors of Theology, were stripped of their title of Doctor or of the designations of PHD or STD following their names. Heaven forbid such an insult.

In the Gospel of Saint Luke, our examination reveals the elimination of another important word. In The Catholic Douay Bible, the Gospel of Saint Luke, chapter 2, verse 35 reads:

“And thy own soul a sword shall pierce, that, out of many hearts, thoughts may be revealed.”

The King James Version reads:

“Yea, a sword shall pierce through thy own soul also, that the thoughts of many hearts may be revealed.”

The New American Bible reads:

“And you yourself shall be pierced with a sword, so that the thoughts of many hearts may be laid bare.”

What in the world happened to the word SOUL? How does the translation agree with the prophecy of the verse? Was the soul of Mary or the body of Mary pierced with a sword? Humanists do not like the word soul, for it speaks of our spiritual being, the very real reason for our existence, and the belief in a life hereafter. A close examination of The New American Bible reveals that the word SOUL has been eliminated in virtually every instance. Why? They are humanizing the minds of their readers and followers. (Are you one of them?) The first mention of the word SOUL appears in the book of Genesis in a footnote which explains verse 26 of chapter 1. The verse reads: “...and let us make man in our image and likeness”. The footnote in the Catholic Douay Bible reads:

“Let us make man to our own image. This image of God in man, is not in the body,

but in the soul: which is a spiritual substance, endued with understanding and free will.”

A footnote for the same chapter and verse in The New American Bible reads:

“1, 26: Man is here presented as the climax of God’s creative activity: he resembles God primarily because of the dominion God gives him over the rest of creation.”

The explanation given in The Catholic Douay Bible is Catholic teaching. The explanation found in The New American Bible presents the perverted teaching of the heretical philosophy of false Humanism.

We see this again in the Gospel of Saint Matthew: chapter 16, verse 26.

The Catholic Douay Bible reads:

“For what doth it profit a man, if he gain the whole world, and suffer the loss of his own soul? Or what exchange shall a man give for his soul?”

The King James Version reads:

“For what is a man profited, if he shall gain the whole world, and lose his own soul? Or what shall a man find in exchange for his soul?”

The New American Bible reads:

“What profit would a man show if he were to gain the whole world and destroy himself in the process? What can a man offer in exchange for his very self?”

We see in these examples that the word SOUL is missing in these verses as found in the mistranslations of The New American Bible. We find that these erroneous translators of The New American Bible have substituted a human, bodily term, such as being, heart, such as a one, one, I, he, himself or person, virtually in all instances where the word SOUL is used in the original Latin Vulgate. The Latin Vulgate was translated from the original language texts by Saint Jerome in the Fourth Century. He spent 30 years in the desert doing that. Remembering that this 1970 edition of the new New Testament of The New American Bible is the official text of the new (new ordo) “church”, it is easy to see why the word SOUL is eliminated in the “new ordo” liturgy. Following the prayer “Agnus Dei” (Lamb of God, who takest away the sins of the world, have mercy on us.), the True Catholic Church says in its True Mass: “Lord, I am not worth that thou shouldst enter under my roof; say but the word and my soul shall be healed.” The ‘new ordo’ sect (still called “catholic”, unfortunately) says in its perverted liturgy: “Lord, I am not worthy to receive you, say the word and I shall be healed.” The word SOUL is obviously missing. “Lex orandi, lex credendi.”; “the law of praying is the law of belief.” Eventually, anyone belonging to the new ordo sect will neither act as if they have, or believe that they have a soul. Other concepts and theological expressions

are also attacked by these erroneous translators. The word HELL is replaced by their use of the terms “nether world” and Gehenna”. This indoctrination takes the reader’s mind away from the central focus of our existence, which is to save our SOUL, to avoid the eternal fires of HELL, and to thus achieve eternal happiness in Heaven. In the Gospel of Saint Matthew, chapter 2, verses 1-12, we read, on the Feast of the Epiphany, in the Catholic Douay Bible the term “Wise Men”. The New American Bible uses the word “Astrologers” to refer to the visitors from the East. Since when are they astrologers? They were astronomers, not astrologers. There is a very big difference between these two words. An astronomer is one who studies the science of the Heavenly bodies. An astrologer is one who believes that the Heavenly bodies control our lives and our destinies. Astrology and belief in it is forbidden by the First Commandment. Astrology is forbidden because it is superstition. What liars these deceivers are! How aggressively arrogant they are! The Wise Men were not superstitious astrologers who are to be condemned, but were the first Gentiles to offer gifts and adoration to the Christ Child. In addition to the elimination of certain theological words, these erroneous translators have also deliberately reduced their liturgy and their version of scripture to the baseness of common, ordinary, every day street language. This is another example of the leveling process. Let us examine verse 18, found in chapter 22 of the Gospel of Saint Matthew:

The Catholic Douay Bible reads:

“But Jesus knowing their wickedness, said: “Why do you tempt me, ye hypocrites?”

The King James Version reads:

“But Jesus perceived their wickedness, and said, why tempt ye me, ye hypocrites?”

The New American Bible reads:

“Jesus recognized their bad faith and said to them, “Why are you trying to trip me up, you hypocrites?”

Can you imagine Our Lord Jesus Christ, Almighty, All-Powerful, All-Knowing, All-Perfect and full of the Most Perfect Dignity saying, “Why are you trying to trip me up?” These infamous erroneous translators of The New American Bible have blasphemously placed this base thought, of Christ speaking this street language into the minds of their readers. In so doing, they are reducing Him, the Son of God, the Second Person of the Blessed Trinity, to the lowliness and depravity of the actual hypocrites to whom He, Himself is speaking. My first impression when I read this “trip me up” mistranslation was an image of the gang hanging around the pool hall or the corner party store. My impression visualized the gang saying in dialectical slang, “Hey you guys, what’s goin’ on here? Are you puttin’ me on, or what? You ain’t tryin’ to trip me up, are you? Come on now, give me a break.” Christ did not speak in these common street language terms. He did not bring Himself down to the level of those with whom He spoke, as do those renegades who

are leading this present day revolt away from Christ and His Church! His intent, in all that He said and did, was and is to lift men up to the Divine, not to drag them down into the gutter. Throughout their perverted text, one constantly sees the uplifting of the human person, not to the Divine, but to a better earthly condition, the inferred teaching of their philosophy of the DIGNITY OF MAN and the FAMILY OF MAN, and the humanizing attempt to debase and destroy the dignity of the Faith. They leave no stone unturned in their quest to spread the heresy of Humanism.

Keep in mind that The New American Bible is the official text of the New Ordo Religion, believe it or not, and in so being, is the text followed in their liturgical services, yes services, as in protestant services. As our final analysis of the mistranslations of the text of The new New American Bible, let us examine verse 28, chapter 26 of the Gospel of Saint Matthew, and verse 26 of the Gospel of Saint Matthew, and verse 20, chapter 22 of the Gospel of Saint Luke, considering their relation to the use of the words of consecration in the Mass.

In verse 28, chapter 26 of the Gospel of Saint Matthew, The Catholic Douay Bible reads:

“For this is My Blood of the New Testament, which shall be shed for many for the remission of sins.”

And in verse 20 of chapter 22 of the Gospel of Saint Luke, The Catholic Douay Bible reads:

“...this is the chalice, the New Testament in My Blood, which shall be shed for you.”

Based on the text of these verses, the Holy Catholic Church uses these words in the consecration of the Holy Sacrifice of the Mass:

“.....for this is the chalice of My Blood, of the New and Eternal Testament: The Mystery of Faith: which shall be shed for you and for many unto the remission of sins.”

The Catechism of the Council of Trent, published under the direction of Saint Charles Borromeo, especially for use by parish priests for the proper instruction of the Faithful, offers this explanation for the choice of words used by the Church in the consecration of the wine:

“The additional words for you and for many....were joined together by the Catholic Church under the guidance of the Spirit of God. They serve to declare the fruit and advantage of His Passion. For if we look to its value, we must confess that the Redeemer shed His Blood for the salvation of all; but if we look to the fruit which mankind has received from it, we shall easily find that it pertains not unto all, but to many of the Human Race. When, therefore, (Our Lord) said: for you, he meant either those who were present, or those chosen from among the Jewish people,

such as were, with the exception of Judas, the Disciples with whom He was speaking. When he added, “and for many”, He wished to be understood to mean the remainder of the elect from among the Jews and Gentiles.

With reason, therefore, were the words for all not used, as in this place the fruits of the Passion are alone spoken of, and to the elect only did His Passion bring the fruit of salvation. And this is the purport of the Apostle when he says: “Christ was offered once to exhaust the sins of many.” (The Epistle of Saint Paul to the Hebrews, chapter 9, verse 28); and also of the words of Our Lord...” I pray for them; I pray not for the world, but for them that thou hast given Me, because they are Thine.” (The Gospel of Saint John, chapter 17, verse 9) (The them and the they refer to the elect, that is, those who will be saved, known by Almighty God from all eternity. (End of quotation from the Catechism of the Council of Trent.)

All of this and much more (Liturgical Dance and Electric Liturgies) did not happen by formal decree on December 9, 1965, the day after the formal close of the “council”. If it had, the people would have revolted. This has happened, one change at a time, the people accepting first the one, then the next, then the other, then another, following a process of gradualism over a period of 25 years. Each and every step of the changing process was taken carefully in its planned time. Rome filtered the objectives to the National Council of Catholic Bishops, which distributed them to the Diocesan Liturgy Conferences which explained them to the clergy, who took them to the local parish Liturgy Committee, which studied each change and decided how to run each change through the processing mill to the people. I know this for a fact, because my son was the Liturgy Committee Chairman of Regina Coeli Parish in Toledo, Ohio from 1973 to 1975. “Peace Priests” carefully explained each and every step to the people, encouraging them to accept each change and prepared them to accept the next. My son experienced this personally with three of them in his parish. It is not over yet. There is much, much more to come. This is only the 25 year point. This new “church”, rather than never-changing, as in the True Church, is intended to be ever-changing ad infinitum, ad nauseam. In the True Church, the only thing that changes is the bread and wine into the Body and Blood of Christ. In the new church, the only thing that does not change is the bread and wine into anything.

“Paul VI” introduced his modernized Masonic religion of man (heresy of False Humanism), honoring man while showing contempt for all legitimate popes and saints of the True Church from Saint Peter to Pope Pius XII. Catholics honor Christ with the title “Christ the King”. A true pope, being the Vicar of Christ on Earth, represents the Monarchical Dignity of Christ on earth. The Papal Crown, called the Tiara, and the Papal Ring, representing the continual Apostolic Succession from Saint Peter to the present time, are symbolic representations of the monarchical significance of the office of the pope. High Masons hate monarchies, kings, popes and the Catholic Church, and they despise anything which is representative of a monarchy or royalty. “Paul VI”, on October 4, 1965, gave away the Papal Tiara and the Papal Ring to the Masonic Communist controlled United Nations in New York and told them in a public address before

their General Assembly that the United Nations was the last great hope of the world, not God or the Catholic Church, as he would have said, if he had been a true pope, or even a Catholic. However, he acted as he did, because he was an anti-Catholic, Masonic Anti-pope. He also lifted the ban on joining Masonic lodges, because he said there was no problem with Masonry anymore. "Catholics", he said, "could now join Masonic lodges with no problem of conscience." This was a complete contradiction to eight true popes who had specifically forbidden membership in the Masons and other secret societies under pain of excommunication from the Church. "Paul VI" finally died. May God have mercy on his soul. His body decomposed in two days and created such a stench in Saint Peter's Basilica that it presented a major problem to those in charge of the funeral arrangements for him to lay in state. Fans had to be installed at Saint Peter's to dispel the odor. This was unprecedented and unheard of in the history of the True Catholic Church. This occurrence was reported on TV and by the national wire services in major newspapers, with photographs.

"John Paul I" (Luciani) was then chosen. Luciani was among the first to be named bishop by "John XXIII" (Roncalli) very shortly following his selection as Masonic Anti-pope in 1958. "Paul VI" named him Cardinal in 1973. "He was an Italian whose father was a Socialist Party activist." (Detroit News special color layout in September, 1978) He was the first in the history of the Church to select a double name (John and Paul), both the names of his immediate predecessors. In the line of false popes, he was the first in the history of the Church to attach the Roman Number I behind his name before number 2 (II) came along, a definite and deliberate break with a long standing tradition and simple logic. Saint Peter is Saint Peter, not Peter I. The same applies to all following popes: Saint Linus, Saint Anacletus, Saint Everistus, Saint Telesphorus, Saint Hyginus, Saint Fabian, Saint Vigilus, Saint Severinus, Saint Christopher, Saint Conon, Saint Adeodatus and all other popes whose names were never chosen by another pope. If one chose a name never previously chosen, such as Pope Gregory (560 A. D.), the Roman Number I was not added to his name until another pope chose the same name again at a future time, for example: Pope Gregory II (715 A.D.- 125 years after Pope Gregory). Only in 715 A.D., did the first Pope Gregory's title change to Pope Gregory I. This was the tradition of the Church continually held for more than 1900 years by 261 popes. So, in September, 1978, when my son unfolded the Detroit News full page color layout picturing the new pope and showing his name as Pope John Paul I, he knew as a Catholic that there was another Satanic fox in the Vatican henhouse. It was a dead giveaway that the enemy was up to no good. Did "John Paul I" and those around him know there was going to be a "John Paul II"? He did not know, however, that his pre-named successor would follow so quickly, for he died a short 33 days following his selection. May God have mercy on his soul. The circumstances surrounding his untimely death are said to have been suspicious: no illness, a quick burial and no autopsy. His controversial death has been the subject of at least one television special and was featured in the movie Godfather III. We wonder what he did wrong! Even though his tenure lasted only 33 days, he still had ample time to announce to the world his adherence to heresy. His very first announcement was the selection of his title, "John Paul I". This was a clear signal

that he fully intended to follow in the footsteps and give honor to his two immediate predecessors, “John XXIII”, and “Paul VI”, both of whom had already undertaken the destruction of the Faith of millions with their perversions. His announcement positioned him as the third Anti-pope in a row in the 1960s. He took no steps to reverse any of their actions, having once appeared to have been an orthodox seminary professor, he did say that at one time he had taught in the seminary that “error has no rights”. This is the teaching of the Church. It means that the teachings and the practices of the Church are true in that the Church is guided by the Holy Ghost, the Spirit of Truth. Any error or teacher of error has no rights against the True teaching of the Church. Error or its teachers are not permitted an equal footing or position with the Truth. In September, 1978, Luciani said that he now knew that he was wrong to teach that “error has no rights” because, he said “The Church was wrong.” If he did not repent of this blasphemy and his adherence to heresy before his untimely death, his soul was in grave danger.

Now enters Karol Wojtyla, choosing the name “John Paul II”, hailing from Communist Poland. Strangely, almost no one outside of Poland had ever heard of him before his selection. He was touted as an anti-Communist, having supposedly fought the Communist Regime in Poland for years. Anyone who has lived in a Communist country will tell you that this is impossible. He traveled freely around Communist Poland and Europe, while Cardinal Wyziniski and other prelates languished in prison.

The very first thing that Communists do when they take control of a country is to round up and imprison or kill all political and religious leaders, especially Catholics, whom they know will oppose the Communist ideology of Atheism, that is, there is no God but the State. This has happened systematically in Russia, Lithuania, Estonia, Latvia, Hungary, Poland, Romania, Czechoslovakia, Yugoslavia, China, Portugal, Spain, Italy, France, Africa, Cuba, South America, Mexico and the Philippines and anywhere else there is Communist control. Priests, bishops and archbishops are killed or imprisoned and never heard of again. The Catholic Church is not permitted to practice openly as an antagonist to the Communist Party, but is forced to re-enter the catacombs and exist hidden from the knowledge of the new government on an underground basis. The only time the non-Catholic public in that given country becomes aware of the underground Church is if a priest or bishop is discovered or betrayed and captured. Recently, this happened in China. On January 20, 1990, there was a brief mention on News Radio Station 95, WWJ, Detroit, that they had a “Report from China of the arrest of ‘agents’ of an underground Catholic Church which does not give its obedience to John Paul II or to Rome”. The incident was reported deep in the back pages of The Philadelphia Inquirer, January 29, 1990: “Beijing-12 Roman Catholic bishops of the underground Church in China in four of the outer provinces were arrested. One was the war hero (Chinese Nationalists versus the Communists) Bishop Anthony Zhang Guangyi, a Franciscan.” Nothing has been seen or heard of this since. As is the case with human nature and the disposition of individual souls, not all Catholic prelates are martyred or disappear. Too many become turncoats and traitors to

their Faith, their flock and their country. They join the ranks of the enemy to save their lives. Some of these turncoats are even imprisoned to give them the proper historical credentials for their future placement. Communists place their own agents in seminaries and throughout the existing Church organization and gradually corrupt the religion with their atheistic perversions, turning the once-fundamental religion into a religion of Socialism, dedicated to man and the State (Remember the Masonic “Hidden Hand”!) Any “church” operating openly, appearing to be in defiance to the Communist State, is actually a Communist-sponsored and State controlled Church. Communists “Nationalize” the church organization just as they nationalize industry and banks.

These Communist plants or spies learn all they need to know about real religious principles, with the help of the turncoats and traitors, and they plot every detail on the subversion and perversion of these same principles so that they may effectively present these principles in different clothing. They then use these perversions to brainwash the minds of the populace and turn them to their own perverted ideology. These pretend, fake, “religious” leaders are often professional actors, called “peace priests”, who tactfully gain the confidence of the people. This process usually takes years to accomplish. Those who resist are killed or imprisoned. Many are “converted” for fear of their lives. In Russia, thousands of leaders of the orthodox religion were murdered and replaced by these Communist agent-specialists. These top orthodox/Communist church leaders now sit on the Communist ruling committee. They induce the people through time-tested propaganda methods into believing that they still have the same religion that they used to have. This past Christmas, we saw Christmas celebrated for the first time in years by the “orthodox church” in Moscow. This was in fact a big Communist show, performed by trained Communist-agent actors. All of this is performed for their own purposes, to control the masses. In about 30 years, no one remains who remembers what the religion originally was. Lenin said that all he needed was one generation of the young to completely communize a country.

“John Paul II” (Karol Wojtyla) is one of these specialists. He continues to be a highly trained professional actor, just as he was in Poland. All one needs to do is to closely observe him on television or read his written works and it becomes obvious that he must be a high Mason, a false Humanist, a Socialist and an Atheistic Communist. He, Karol Wojtyla, wrote a book entitled Osoba I Czyn, Polish for person and action or the acting person. This book was first published by D. Reidel Publishing Company, Dordrecht, Holland. Herbert Springer translated this same book into German and it was published in 1981 by Verlag Herder, Hermasnn Herderster, 4. D 7800 Freiburg in Breisgau. This book is now available in English, under the title Acting Person and can be purchased from: Kluwer Academic Publishers, P.O Box 358, Accord Station, Hingham, MA., 02018. The price, including shipping and handling is \$24.00. If you can tolerate the convoluted and confused mixing of philosophies and illogic, buy it and weep, as you read the words of an avowed Atheist, one who was probably never a Catholic and now pretends to be “pope”. The book itself is very ambiguous and extremely difficult to read. The theme of this book, which we have in our possession, is that dogmatic Christianity

is only one of many erroneous systems, that there is no reward or punishment after death, that Christ is not necessary, and that man is the visible God. The amazing fact is that millions are duped to believe that the author is a Catholic and a pope of the Catholic Church.

The German “Cardinal” Ratzinger, appointed by “John Paul II” as the head of the Vatican “Congregation for the Faith”, whose stated purpose is to safeguard the Faith, also has a book published titled Principles of Catholic Theology. On page 17, he says, “The truth is whatever serves progress, that is, whatever serves the logic of history.” (Remember, this is one of the tenets of Masonry.) On page 42, “We ourselves have become uncertain about our Christian Faith.” On page 141, “Luther’s historical instinct is clearly proving itself right.” On page 186, “The Resurrection cannot be an historical event in the same sense as the crucifixion is.” (Remember the “Vatican II Document which states that the perfection of the Revelation of Christ culminated on the cross?) Does any of this sound at all Catholic? Those who think and write thus are Atheists, False Humanists, Indifferentists, Liberalists, Modernists, Ecumenists, Pantheists, and Pagans.

Every “John Paul II” speech and written document is loaded with ambiguity. One reads them, scratches their head and thinks “What in the world did he just say?” One thing is clear, however, “John Paul II” is always consistent: he always emphasizes the human condition and coexistence with error (true marks of an anti-pope!). “The pope concluded his (November) 1985 encyclical on Saints Cyril and Methodius with a prayer for the unity of Europe, “So that when incomprehension and mutual distrust have been overcome and when ideological conflicts have been conquered in the common awareness of truth, it may be for the whole world an example of just and peaceful coexistence in mutual respect and inviolate liberty.” (Columbia Magazine, November, 1989) This is a prayer? What in the world did he just say? Who is meant to understand what he said? He said this to common everyday people in very lengthy ambiguous terms. Why? This was political propaganda, pretending to be a prayer to Almighty God. In other words, he used God for his personal brainwashing purposes. True popes of the Catholic Church speak clearly and directly to the point in understandable language.

“John Paul II” parades around the world acting the role of a pope. During the reshuffling and restaging of the Communist block countries, the Vatican hastily prepared a trip for him to Czechoslovakia. What was the big rush? The real Vatican of the True Church never did anything hastily. Proper care and vigilant deliberation are always the hallmark of its actions. “John Paul II”, as is typical of his “Wojtyla Circus”, as it is called by Vatican personnel, flew in on his plane, brought his pope mobile and announced: “Behold, the night is over and the new day has dawned.” The insiders who know his objectives know that he meant- the night of darkness (the Dark Ages) of the real underground Church and the day of unrestrained Communism will now prevail. The underground Church was apparently brought to the surface, believing with others the deception and myth that Communism has crumbled. Imagine, in just a few short months, prisoners of the Communist government, called national patriotic heroes are released and

become the leaders of their nations and travel around the world asking for money from the West. This is what we hope for, so this is what they give us. Are we happy, now? Beware, something is fishy in Denmark (or is it Moscow, London, Geneva, New York or Washington, D.C.?). We are told in the news that Communist countries all over the world are all suddenly converting to democracy and that Communism has fallen. People believe that we are experiencing the conversion of Russia. We are told that the Communism is dead. Do not believe this propaganda. This is a well-planned, orchestrated ploy, an underhanded plot, by the Masonic Communists to manipulate the masses. Their old tactics are no longer necessary, having already accomplished the task intended. Now, they move on to the next step. This step has everyone disarming themselves mentally and physically. They change colors whenever they need to in order to proceed and to achieve their own objectives. Anyone or anything is dispensable to achieve the goal. All of this is outlined in the Communist Manifesto, written by Karl Marx. My son studied this and his philosophy as a minor in college. The specific course was The Philosophy of Communism. It is working according to their plan, and most of the world is buying the story, hook, line and sinker. “John Paul II” then talked (reported and quoted on TV and in newspapers) about the long suppressed spiritualism in Czechoslovakia. Spiritualism? Spiritualism is not a word that was ever used to refer to Catholicism and Christianity by Catholics, nor is it now. Spirituality is the Catholic term. Spiritualism is a condemned heresy, as we read in the Catholic Encyclopedia, 1913 edition, page 229. It is a form of heretical Pantheism which states that the universe is God, God is the Universe! This agrees totally with the philosophies presented in his book. Oppression, Aggiornamento (propounded by “John XXIII”, aka “Papa John”), Human Dignity, Coexistence and Solidarity are also key terms employed in the new Vatican Vocabulary. These are not traditionally used Catholic words. They are traditional Communist words signifying union with the revolution. They have been used in Socialist Labor movements for years.

“Power to the People!” In his most recent encyclical, “John Paul II” announced his belief in the “Virtue of Solidarity”. Solidarity? Catholics were never taught that “Virtue”; Catholic Unity, yes, but never “Solidarity”! What is Solidarity? We see both black and white people on television raising their clenched fists and crying out “Solidarity”, Power to the People!”, “Workers of the world, unite! This is straight out of the Communist Manifesto. The clenched fist, of course, is the worldwide Communist battle sign and salute.

“John Paul II” told the Lutherans at an interfaith service, in which he participated, in their Lutheran building in Rome, that Martin Luther was right and the Church was wrong (that sounds just like Cardinal RATzinger, does it not?)(Also, let’s not forget that willfully participating in a false protestant religious service is, according to Catholic teaching, a Sacrilege against the First Commandment (false worship and adoration), and doing so in public constitutes giving bad example, a serious (mortal sin) offense against the Fifth Commandment!. “John Paul II” tramped all over the world giving honor to infidels, heretics and atheists. He has participated in interfaith services with Runcie of the Church of England, the Dalai Lama

(Buddhist), and Metropolitan Methodius of the Eastern Orthodox and others of any kind of belief, including witch doctors in Africa. At this particular gathering in Assisi, Italy, the newspaper photo shows him sitting with heretics and infidels. A statue of Buddha sits right in front of the Tabernacle behind them. Saint Francis of Assisi, Saint Anthony and all of the holy Franciscans must be spinning in their graves at this blasphemy. On October 3, 1979, he stirred a youth rally into a frenzy in Madison Square Garden with his Satanic Growls (We have this on audio tape and watched it on TV.) In a retrospective ten years later, the Vatican officially applauded this insanity and so-called Catholic periodicals printed it. Video tapes honoring him and his activities at Castelgondolfo (The Papal Retreat) and the Vatican clearly reveal “John Paul II” as a poor “real pope actor”. His Latin is terrible and his singing of Gregorian Chant is worse. I speak with some experience on the subject, as my son majored in Latin in high school (twice a day, five days a week) and in College. He was also a participant in the Gregorian Chant Choir during those eight years. During Easter and Christmas telecasts, “John Paul II” regularly, from year to year, sings “Ho, ho, hee, hee and ha ha”, clearly different from those, at the same service, who try to sing Gregorian Chant correctly. The problem and the crime is that he does know exactly what he is doing and has, throughout his entire career. His assignment and objective is to make a complete mockery of the Catholic Religion, the Catholic Church, and the papacy before the entire world. That he is doing with masterful precision, he and the rest of his fellow acting comrades. Whoa to those who mock Christ and his Church: The Prophet Exechiel, chapter 25, verse 3: “And thou shalt say to the children of Ammon: Hear ye the word of the Lord God: Thus saith the Lord God; Because thou has said: Ha, ha upon my sanctuary, because it was profaned: and upon the land of Israel (Israel, the House of Juda and Sion are symbolic of the Church, according to Saint Jerome) because it was laid waste: and upon the House of Juda because they are led into captivity.” God will deliver his punishment upon them. Verse 6, “For thus saith the Lord God: Because thou hast clapped thy hands and stamped with thy foot, and hast rejoiced with all thy heart against the land of Israel..” They will receive the punishment of God. And in verse 8: (and because thy have said) “...behold, the House of Juda is like all other nations...” (for preaching false Ecumenism, that all religions are the same or about the same or have value in the sight of God, and are not in fact the very enemies of God, preaching that evil is good and good is evil!) They will receive the just judgment and punishment of God.) If this Karol Wojtyla has any human sense at all, he should be trembling in his hiking boots.

Tad Szulc, a Jewish reporter and author, wrote the Biography of John Paul II (Karol Wojtyla). In the book he reports that Karol was born in Poland, the son of a Polish (Communist) Army officer and his wife. He delves into the background of the father, praising him and his heritage, but fails to even mention the name of his mother. Her name was Katz (She was a Jew!). Karol grew up and became interested in acting and pursued a career on the stage. He mentions that Karol entered the seminary during World War II, and that this seminary was a secret seminary where not one student knew another student. (I never heard of that kind of seminary before!) He became a priest and was promoted to bishop. While all prelates who opposed the Communist Party were in jail, Karol had the freedom to

roam around the country and to roam around all of Europe working with youth groups. Somehow, he was such a diplomat, that he was able to get along with the Communists! When Rome was planning to have a conference of bishops from around the world, the Vatican sent a list of those they wanted to attend to the Polish Government. All names were denied. The Vatican sent another list. All names were denied. There was only one name left which had been deliberately not included in the two previous lists, Bishop Karol Wojtyla. That name was reluctantly submitted. The Communist Government gleefully allowed him to go to Rome. Of course, he was “known as a staunch anti-Communist”.

The principal horror and truth of the entire matter is that the enemies of the Catholic Church are leading millions to perdition. These millions refuse to see that the emperor is naked, having stripped away the truth. They follow along blindly into the depths of Hell just as the children of Hamelin followed the pied piper to their destruction. Christ foretold this massive spiritual blindness. Now, it is upon us, and, very few see what is happening. The obstinacy, the hardness of heart, and the stiffness of neck which led the Jews, the original people and once-chosen Race of God, into massive spiritual blindness, causing them to crucify their long awaited Messiah, has returned. The “Abomination of Desolation” stands in the sanctuary, false christs and false prophets are seducing many; the very organization which pretends to the world to be “catholic” proclaims “Lo, here is Christ and there”. Do not believe them. (Read Saint Matthew, chapter 24 regarding the Second Coming of Christ.) We have seen this happening for years. The process of change after change has gone on for at least 25 years at this point. It will continue. We had seen enough and left in 1969. We hoped and prayed that our families, relatives and friends would also see. Sadly, they did not. During the past fifteen years, we have seen the effects of the erosion, the effect of the “new church” teaching, the influence of Materialism, Ecumenism, Liberalism, worldliness, and close association with pagans of all sorts infect them and their friends. In the sight of God, we must also ask ourselves where we are and why we are there. If we are not in the Church founded by Christ, then we must be in an organization founded by the enemies of His Church, Heaven forbid! A true in-depth examination of conscience is in order. How shall we answer for this on Judgment Day? Remember, no excuses will be accepted.

Why is it that millions fail to see this horror? Is it that they simply do not see it as a horror at all, in that they have been conditioned to believe anything? Do they distort the Promise of Christ to His Church (“And behold I am with you all days, even to the consummation of the world.” (The Gospel of Saint Matthew, chapter 28, verse 20) as meaning that nothing could possibly go wrong, that error could never possibly creep into the Fold of the Faithful and lead millions away? Christ did not say how large the Church would be. He did not say how many millions would belong, but He did say that FEW would follow the NARROW path. This has happened before with the many heresies which have attacked the Church. These heresies were invariably started by those inside the Church or developed in a future variation by them. These errors led those inside the Church to fall outside the Church. Do they think that the statement of Christ found in Saint Matthew,

chapter 16, verse 18: "...I will build my Church, and the gates of Hell shall not prevail against it." offers them special immunity against anything going wrong, that errors cannot take millions out of the Church for centuries or forever? This very thing has happened before and these millions are still outside the Church or have already died outside the Church. May God have mercy on all of their souls. How long does "prevail" mean? Could it mean that those millions did not in fact belong to the elect who were intended to be members of the Church and thus were removed like unwanted debris? Many people are members of the Church as a matter of mere circumstance, but when the real test of their Faith is presented, they fail and wither away, losing their Faith, thus proving that they had no steadfastness in the Faith at all. They are reeds blown in the wind by whatever wind comes along blowing whatever it blows (eloquent speaking false teachers, preaching false doctrines of any kind). "...and these have no roots; for they believe for a while and in time of temptation they fall away." (The Gospel of Saint Luke, chapter 8, verse 13) They were Catholics in name only.

Do these millions feel certain that the pope, the cardinals, the bishops, all of the priests and nuns cannot possibly be wrong? If so, will they give their blind obedience to them, questioning nothing? It seems that they have. They have been wrong before. There have been anti-popes before and they were wrong. One pope, Honorius, was condemned after his death for failing to act upon heretical trends. Thousands of archbishops, bishops and priests and nuns were wrong when they fell into the errors of Arianism, Nestorianism, Pelagianism, Socialism, Protestantism, Masonry or whatever other error, and took millions of souls with them.

Did all of those millions say "Well, I'm ok, because all of these people, including 35 anti-popes, cannot possibly be wrong"? "Dear Bishop or Father so and so could not possibly be wrong." Really? They all thought they were still in the same church they had been in before. They were still in the same building. They sat in the same pew. They still had Father so and so. Did that make them right? They say there are about 800 million "Catholics" in 1991. Does that number make them right? Were the 400 million Catholics in 1940 all wrong? Prior to 1965, there were 261 popes, thousands of cardinals, archbishops, bishops, priests, saints and ordinary Catholics who, by their statements and lives, say this horror of today is totally wrong and devastating. Could these 800 million today be right and all of those who previously lived wrong? Is it simply a question of numbers? Does the majority rule constitute the Truth? If so, since there are more pagans than Christians, is the Holy Ghost wrong? Does God contradict Himself? Is it right that the Church should update its doctrine to fit the thinking of modern man? Man has been modern man whenever he existed. Adam and Eve were modern in their day. God does not change. He never has and He never will ("For I am the Lord, and I change not." The Book of the Prophet Malachias, chapter 3, verse 6). God does not adjust for mankind. Were the Jews right when they crucified Christ? There were only about 72 believers when Christ died. Was everybody else in the world at that time right and the 72 wrong? There were 120 Disciples when Christ ascended into Heaven. Were they wrong? Was the entire world right when they scoffed at Noe when he built the ark following the specific directions of God, cubit by cubit, plank

by plank? Were they right, going along with the majority, when they all drowned? May God have mercy on their souls! They knew then that they were dead wrong. They were all wet, and then it was too late. The entire population was gone, with the exception of eight, only eight (8) in Noe's family. Were Adam and Eve right or wrong when they followed the enticement of Satan, the Master of Deceit, instead of obeying the command of God? They were the only two people in the entire world. They had everything they could ever want and lost it because of their weakness of Faith, their pride, and their belief in the deceptions of the Devil. He made his temptation sound so good. He has not changed one iota since then. People still buy his lies and pay dearly, with their souls. The numbers game simply does not justify error. History proves this fact over and over again. The fact that millions have divorced and "remarried" in the past fifty years does not change the fact that those millions are living, or have died, in adultery, and have to answer for it. The fact that everyone is doing it does not give even one of them the license to do it or to think that they can change the Law of God for their own pleasure and convenience, or that God will now understand because so many are ignoring His Commandments. Right is right and wrong is wrong. It does not matter how many believe anything, numbers do not change a thing. Good is good. Evil is evil. We do know there will be only a few who will find their way along the narrow path, because Christ said so. FEW! FEW! How many is a FEW? In the time of Noe, eight were the FEW. Only God knows what the number of the few will be. Whatever the reason is for our inability to see these things is the reason for our spiritual blindness, which Christ Himself foretold. There are as many reasons as there are grains of sand on the earth and stars in the heavens. The bottom line, the end result is that Satan has trapped millions of us into believing his masterful deceptions by our own personal acts of rationalization. Self-deception is one of the most effective traps of rationalization. The underlying reason for our cooperation with error is our lack of cooperation with the Grace of God. The loss of the Holy Sacrifice of the Mass and the Sacraments of the True Church means that the sustaining Grace of Almighty God has been removed from this world. Without this Grace, the Devil is unchained. Evil will increase in ferocity. Horror will build upon horror. We have only begun to see the effects of this loss. The world is following this course as if it were on a runaway freight train plunging down a steep mountain slope.

Catholicism is NOT based on emotionalism, Pentecostalism, Charismatic Action or anything designed to falsely stir up feelings and emotions for short periods of time. Catholicism is based on the teachings of Christ. It is based on fact. It is based on Truth. It is based on Faith. It is true. It is real and cannot be changed or denied, without meriting the punishment of God.

The "Vatican II church", the "Conciliarists", the "New Ordo Sect", the "new church", or whatever one calls the new church that used to be the Catholic Church launched by the so-called "Vatican Council II" is NOT the Catholic Church. If you still belong to it, your soul is in grave danger. Why? Because you are outside of the Catholic Church and there is NO salvation outside of the Catholic Church. That is a fact that cannot be disputed. The Conciliarist enemy has left no stone unturned.

They want your soul. This new “church” composed of the “new people of God” (council document term) is a complete reversal of Catholicism. If you do not know that, then you do not know your faith. I am very, very sincere about that. You are going to have to face that simple fact. They say one thing and do another. They abide by no laws. They answer to no one. They need permission for nothing. If they want to do something, they do it. Anything is ok, except that which is Catholic. I’m ok (well, not me), you’re ok, everything and everybody is ok, except that which is truly Catholic. That is the new doctrine of the new apostate church. Apostasy is the complete reversal of Truth. This is apostasy. They have granted thousands of annulments and allowed “remarriage” after divorce. They act openly as if those outside the Church possess valid and licit orders, that they have a mission from Christ to preach, that they have Apostolic Succession, rejoicing with them in their mutual endeavors to lead millions astray to Hell for eternity. They participate in their services and provide once-Catholic buildings for heretical use in addition to their own. Just recently, “Archbishop Szoka of Detroit attended the installation of an Episcopal “bishop” of Detroit. WHY? What reason is there for attendance or celebration of this event? The True Catholic Church has formally proclaimed that the Anglicans/Episcopalians do not have valid and licit orders, that they do not possess Apostolic Succession, that they do not have the authority of Christ to preach, that they do nothing that is pleasing to God. Why publicly give honor to those who pretend that they do, when they do not? These are the Anglicans and Episcopalians who have authorized divorce and remarriage, birth control, abortion, and the new female and lesbian homosexual ministers (mistresses). Why celebrate anything with them? Why? You do so if you are a fellow heretic. Heretical birds of a feather do flock together. “Cardinal Krol” of Philadelphia authorized the use of the once-Catholic Saints Peter and Paul Cathedral (Built in 1856 by Catholics under the auspices of Venerable Bishop John Neumann) for the use of Lutherans to install their new “bishop” Lawrence L. Hand. “Cardinal” Krol, now retired, attended the ceremony with his replacement, the newly appointed “Archbishop” Anthony J. Bevilacqua. Lutheran “Bishop” Hand died four years later while dancing at a wedding reception, and full funeral procedures were conducted in the same once-Catholic Cathedral. This time, “Archbishop” Bevilacqua of the Philadelphia “catholic” Archdiocese participated (Committing a Sacrilege against the First Commandment and giving bad example against the Fifth Commandment). During the “instant canonization” ceremony, “Archbishop” Bevilacqua declared to the congregation that “Bishop” Hand was “a true friend” and “I rejoice above all that he still lives in the company of the angels and saints in Heaven.” (Philadelphia Inquirer, March 4, 1990). This is insane! This is heretical. People will believe anything if they hear it often enough. “Archbishop” Bevilacqua’s (we call him Devilacqua) actions state that this Lawrence L. Hand was a bishop of the Church, and that he had gone directly to Heaven. He did not have to pass Go or collect \$200, no detours, no delays, he just went straight to Heaven. Obviously, according to these heretics who have taken over the Vatican and the former Catholic Church buildings think and preach that all of us folks are in one big happy church. The truth of the matter is that Lawrence L. Hand was a public, apparently un-repentant first class heretic. How could anyone say that he has gone straight to Heaven. What ever happened to

Purgatory? And Hell? Anyone who says that is a first class heretic himself, and Bevilacqua is just that.

The Philadelphia Inquirer photo of this funeral service reveals one female minister dressed in full vestment regalia behind the table of service, all of this taking place in the once-Catholic Cathedral building. Are they trying to prepare the people for female priestesses? Yes, they are. “Archbishop” Bevilacqua also authorized the use of this Cathedral, still named Saints Peter and Paul, for use by the Episcopalians to celebrate their new “bishop”. Why? Well, they have done it once, so it must be ok to do it again and again. The precedent has been set. The public has accepted it and has been duped. Let’s move on, and dump some more indoctrinating poison into their awaiting brains. This will soon be the cathedral of the one big including everybody church of Philadelphia. On Sunday, January 13, 1991, the Cathedral Chapel of Our Lady of the Most Blessed Sacrament will be used to celebrate the eighth annual interfaith commemorative service in honor of “Reverend”, Doctor Martin Luther King, Junior. Does this surprise anyone? This Martin Luther King was a public heretic, and at best, if he were not an actual card carrying Communist himself, was regularly associated with those who were. For just reasons, he was constantly kept under surveillance by the FBI for suspicion of subversion. Why would anyone who thinks themselves Catholic want to celebrate an occasion to give honor to this man? We received a formal invitation to this event from the Office for Black Catholics of the Archdiocese of Philadelphia. This event was advertised on the Archdiocesan television show Reel to Reel. Did we go? Please! Have they all gone insane? No, all is going according to their well thought out plan. Do they care that this is an outright insult and blasphemy against Almighty God, his Most Blessed Sacrament and Our Lady, the Blessed Virgin Mary. No, why should they? If you are an enemy of Catholicism, anything goes, anything at all. Can anyone imagine any Catholic Church, much less a Diocesan Cathedral, conducting an event designed to give public honor to a protestant minister heretic, much less a Communist?

The “Archdiocese” of Philadelphia produces and edits a television show called The __ASS. Yes, this blasphemous logo is displayed on the screen as they begin their silly performance. Two golden triangles are supposed to represent the capital M, but failing to do so because they are somewhat transparent, all that the eye perceives are the printed letters: THE __ASS. It is listed in the TV Guide as “Church Service-Catholic”. Recently, they displayed a new piece of hideous artwork which they call a crucifix. It is a piece of crossed boards or metal through which it appears a cartoon figure of a man went crashing. There is no corpus, but simply a figure sized hole. It reminds one of the Tom and Jerry or Tweety and Sylvester cartoons, when one of the cartoon figures would crash through a door or wall and one would see a hole in the door or wall in the shape of the cartoon character. They made a big deal of introducing this mockery as a beautiful, treasured piece of art, which would be inspiring to all. Were we inspired? How pathetic they are! This blasphemous depiction, supposedly of Christ on the cross, is another mockery of Christ and of His Church perpetrated by those who falsely pretend to be Catholics.

This and other mockeries are presentations of a new religion which preaches “Good is evil and evil is good; beautiful is ugly and ugly is beautiful.” In the True Catholic Mass, the priest prays “Receive, O Holy Father and Eternal God, this spotless host, which I, thine unworthy servant....” While in this television service (for shut-ins), trying to imitate the true Mass, the minister says, “Thank you Lord for counting us worthy to be in Your Presence....”. What an amazing complete opposite difference. That is exactly what it is, the very antithesis of the True Mass (Apostasy). Another phrase from the regular script is “Father, You alone are holy...” This is not a Catholic prayer, but is taken from the Jewish Seder Service. This statement implicitly denies the existence of the Blessed Trinity. Remember that prayers to the Blessed Trinity and to the Holy Ghost have been deliberately removed from their new “mass” service. Why? Jews do not believe in the Blessed Trinity, for they do not believe that Christ is God. They deny that He is the Son of God, therefore they recognize only one person in God, God the Father.

Every Sunday, they pronounce another heresy or blasphemy. One “Father” so and so stood up and imitating his four year old nephew, went through an acted out tantrum fit, using God’s name in vain, thus breaking the Second Commandment of God, giving bad example to those present (the Fifth Commandment), then said that Christ’s death on the cross was a “warm fuzzy” for us! He said that he always carries a warm fuzzy in his pocket, which he showed, and that he keeps one at the rectory. This warm fuzzy, of course, is a symbol of humanistic transactional analysis. It is certainly not Catholic teaching, which one would expect from a Catholic priest. Another one said that Christ wanted us to feel close to His Father, that we should call Him “Dad”. Imagine calling God, the Father, “Dad”! What lack of respect and blasphemy! Another one used the term “our common God”. Another charismatic character rattled off gibberish which he said was speaking in tongues, then immediately offered a memorized interpretation of his gibberish. What a fraud! Another minister (“priest”) stated, “Just as Christ became aware of the Will of His Father, so should we.” This is an insidious denial of the Divinity of Christ. Christ did not, as he matured, become aware of the Will of His Father. Christ is God. Christ is the Second Person of the Blessed Trinity. He does not, as we humans, become gradually aware of knowledge. Christ, as God, was completely aware of the Will of His Father as an infant in the crib in Bethlehem, as He was when He ascended into Heaven. This non-believing heretical “priest” minister of the new religion showed publicly on TV that he did not understand this. He, among others, were typical local Philadelphia minister “priests” selected to perform on the Sunday TV show for shut-ins. Another statement used in the “service” each week implicitly denies the existence of Hell and the Promise of Christ that those who do not believe will be condemned, and that these unbelievers will suffer eternal damnation and the fires of Hell. This statement is, “Almighty Father, we ask that all those who have died with the hope of rising again, and ALL the departed, be brought into the light of your presence.” This is an impossible prayer. It assumes that no one shall suffer the punishment of Hell, that ALL will be saved (a teaching of the new religion). It assumes that no one will suffer the punishment of Hell, that all will be saved, no matter what their sinful condition and lack of repentance. They might as well ask God to change a triangle into a

circle. This is another example of how they have changed the prayers of the Mass and their entire meaning. What they are imitating is one of the Memento prayers of the True Mass that reads, “Remember also Lord, thy servants and handmaids, who are gone before us marked with the sign of Faith and sleep in the sleep of peace. To them, Lord, and to all that rest in Christ, grant we beseech Thee a place of happiness, light and peace, through the same Christ Our Lord. Amen” What an amazing difference and opposite meaning versus, “Almighty Father, we ask that all those who have died with the hope of rising again, and ALL the departed, be brought into the light of your presence.” In every broadcast, they prove over and over that they are not Catholic. The Director of Communications of the Archdiocese is a chummy young fellow who does not even have a command of the English language. That is a minor problem, even though this is done on purpose in order to mock the Catholic Church, which they falsely claim to the world to be. This minister (so-called priest), on a particular Sunday, mocked Christ by saying that it “was not a very nice of Christ” to call the Canaanite woman a “dog”. This protestant minister, posing as a Catholic priest, was doing his devilish best to make the point that “divisions should not divide us”, that “we are all members of God’s household”. He was trying to teach the heresy of False Ecumenism, the favorite heresy of this new religion of this new church. As he did so, he regularly employed street language. The Truth is that we are all Children of God, but if any are not members of the Catholic Church, then they are not members of the household of God, no longer members of the Mystical Body of Christ, the Catholic Church. Think about this as a matter of pointed reality. If a Catholic had fallen asleep in 1950, and were to wake up today, and tune in to this show or walk into one of their churches during one of their “services”, they would have no doubt that they were watching something non-Catholic. Their choirs are more like non-Catholic Gospel singing groups and Holy Rollers than the main line non-Catholic ones are. Their ministers are more non-Catholic than any non-Catholic protestant ministers are. The people in the audience and in the pews sit there week after week and take it all in as zombies who think it is so amazingly wonderful. They do not stand for the Gospel, nor do they kneel for any reason. They smile, chuckle at the jokes, yawn and stare. How those who still think they are Catholic can sit by and say that this is the Catholic Church which is presenting these blasphemous mockeries is a real puzzle. They rightfully deserve what they are getting, because this is further proof that the spiritual blindness, foretold by Christ Himself for these times, has taken its effect upon millions of poor souls. The longer they remain in Satan’s trap, the worse it gets, and the eventual chance of their escaping diminishes to the point of impossibility.

If one really thinks one is a Christian, whether one calls oneself Catholic or Protestant, why does one waste one’s time and God’s precious time going to their Masonic buildings, participating in the one world religion, and even though one does not fully realize it, one is blaspheming God and His Church. For the sake of their immortal souls, they should please listen and leave before it is too late. The longer one stays, the more difficult it will be to leave. It has now been 41 years since the founding of the new religion and its new church, December 8, 1965.

Outside the Catholic Church there is no possibility of obtaining Sanctifying Grace, Actual Grace, yes, Sanctifying Grace, no! One cannot go on thinking that one is capable of leading a “holy” life, pleasing God by doing His Will, when one is outside of His Church. Thinking thus is nothing more than self deception and a contradiction of Truth. Holiness does not exist outside of the Catholic Church, no matter what any false church or preacher now teaches. When we look at the Novus Ordo that claims to be the Catholic Church today, and compare it to the real Catholic Church in which we were reared, it becomes absolutely clear that there is no possible way under the sun that it and its new religion is Catholic. It is even more terrible in the sight of God than the previously established non-Catholic religions. It agrees totally with Protestantism and goes beyond it in denying more truths of the Faith. Even some protestants are concerned about this. Recently, there was a notice in a local paper that the Sunday sermon in the local Lutheran building would be What the Catholic Church Should Not Compromise. A video with the same title would be presented. Whatever the new religion organization does has the intention of pleasing protestants, Jews and infidels, but certainly not God. There is a legally blind 61 year old “catholic” minister here in Avalon, New Jersey, who, because he has a white beard, thinks it is cute to wear a Santa Claus cap during Christmas “mass”. So-called “Catholic priests” are being arrested for molesting children and are dying of aids and being praised for their courage in enduring the punishment visited upon them as a result of their sinful lives. All of this goes on and on and no one seems to be concerned that these blasphemies are occurring because the Holy Sacrifice of the Mass, the priesthood, the Sacraments and the Grace that is derived from them, have all been lost. Why is there no concern? Those who remain in the grip of the new religion are following a leader who is the master of absurdity, and the master of deception.

In 1980, “John Paul II, at the World Synod of Bishops, proclaimed that “Divorced Catholics who marry outside of the Church can and ought to participate in the life of the Church, but could not receive communion unless they abstain from sexual relations. By virtue of their Baptism, they can and ought to participate in the life of the Church by praying, by hearing the word, by assisting at the Eucharistic Celebration of the community and by fostering charity and justice. Remarried Catholics, however, cannot take the Sacraments unless they live in a manner which is not opposed to the indissolubility of Marriage.” An American “priest” stated that “The Pope is simply reaffirming the Traditional Church stand.” (The Philadelphia Inquirer, October 26, 1980) What he meant, of course, by tradition and church was that which began in 1965, certainly not the True Catholic Church. These people are such jokesters and blatant liars, it is scary. This was not a misprint or misunderstanding by the reporter. This is the official policy and teaching of the new religion organization. The 1988 Catholic Almanac, on page 236, states with regard to those who are divorced and “remarried”:

“Sacramental participation is not possible for those whose first marriage was valid, although there is no bar to their attendance at Mass, to sharing in other activities of the Church, or to their efforts to have children Baptized and raised in the Catholic Faith. An exception to this rule is the condition of a divorced and remarried couple

living in a brother-sister relationship. Unverified estimates of the number of U.S. Catholics who are divorced and remarried vary between six and eight million.”

This is not a joke. This is the official position of the new religion that calls itself Catholic. Yes, it is a new religion, and it is not the Catholic religion. The Catholic teaching is that if anyone divorces and remarries, they are excommunicated from the Church. No sacramental participation is permitted. Children of such a union cannot be baptized in nor reared in the Church. The parents do not qualify as Catholic parents.

The 1988 Catholic Almanac article then mentions that the new religion organization in the United States issued 53,320 annulments in 1985. That is 53,320 cases in the United States alone and in only one year. That is an average of 1,066 per state, in one year. On the same page 236, it then states that “The tribunal way to a decree of nullity regarding a previous marriage, however, is not open to many persons in second marriages.” Wow! 53,320 in one year is not many? Notre Dame Stadium packs 53,000 fans into its seats for every home game. That appears to be a lot of people. Let us take this one more step to accentuate this absurdity and picture ourselves sitting in Notre Dame Stadium on a cool Saturday afternoon in October; the announcer addresses the assembled crowd: “Ladies and gentlemen, welcome to Notre Dame Stadium. The official attendance today is 53, 320. All attending this event were granted an annulment from their marriages this year, and are free, if they wish, to marry someone else. Father Hesbergh will now give an address which will explain the great difficulty of obtaining a nullity of marriage, showing that this is not open to many, and will discuss your church’s stand on the indissolubility of marriage. Following his address, we will have a celebration of annulment. After all, we do celebrate everything. Does this make this absurdity more clear? In our many years as Catholics, prior to “Vatican Council II”, we had never heard of a single case of annulment. Now, how could there be 53,320 unions dissolved in just one year in one country because there was not, in fact, a valid marriage in the first place? This is a true example of the real practice with regard to the indissolubility of marriage of the new ordo organization (that still calls itself “catholic”) and its typical practice of contradicting itself. To them, marriage exists only as long as love exists. When incompatibility arises, the marriage ends. Of course, Christ Our Lord made no mention of incompatibility. He did, however, say: “My Grace is sufficient for thee.”

Even though the new ordo church talks about, that is, gives lip service to, the indissolubility of marriage, its actions speak louder than its words. News events continually show that which is really believed and practiced. For example, two recent events should suffice: first, the announcement of the death of the “husband” of a famous European princess. This princess was already married prior to her entering into an adulterous relationship with this person. She married, divorced, and entered into another “romantic union”. The “significant other” of this latter union was killed in a speedboat accident. The new ordo church organization, however, gave him all of the ritual proceedings of a funeral service in their cathedral, with the bishop presiding, and burial rights, just as if he had been a

faithful Catholic, and announcing to the world that it approved of this illicit, adulterous relationship. Secondly, the same sort of incident occurred one week later in Philadelphia. The “wife” of a Philadelphia professional athlete died as a result of complications following childbirth. The couple had three children; two of their own (one of these was adopted) and one from a previous marriage. This was another divorced and remarried situation. The new ordo team chaplain asked that “God have mercy on her beautiful soul”. Does living and dying in the act of adultery make one’s soul beautiful? She received full new ordo catholic funeral proceedings at Our Lady of Good Counsel Church and burial rights, just as if she had been a faithful Catholic. The absurd brother-sister new teaching appeared again in the news on the Paul Harvey Radio newscast when he described a situation in South America of two cases in which two priests were discovered to have secretly married. He said the Vatican’s decision was that these priests could continue the relationship with their spouses if they lived together as brother and sister. To that Vatican announcement, Paul Harvey said, “One response the Church cannot afford, is to be laughed at.” Yes, it is a pathetic joke. It is a new religion. Unfortunately, it is not funny. It is blasphemous.

These statements and examples of this religion sect represent the direct opposite of the teaching of the True Catholic Church. Divorced remarried Catholics are not remarried and are not Catholic. They are expelled from the life of the Church and are deliberately not permitted to participate in it. It is clear that they are living in public adultery. So-called remarried Catholics can be reconciled to the True Church only if they separate from their partner in adultery. The fact that these remarried are living in adultery is explicitly stated by Christ Himself in the Gospel according to Saint John, chapter 4, verses 16-19. What absurdity for someone who claims to be a pope to make such statements, contradicting Christ Himself. If a divorced person enters into a union with another person, engaging themselves in a civil contract, is it at all logical to think that they will not participate in an adulterous sexual union? Is it logical that their intentions will be to live together under the same roof as brother and sister, and not have sexual relations? This is sheer absurdity. What happened to the principle of the “occasion of sin” in their new religion mindset? The True Catholic Church has never approved of any “brother and sister” relationship of an unrelated male and female living together under one roof, for this would constitute a daily occasion of sin, which is tantamount to committing the sin itself. How can people accept this “John Paul II” new order church double-talk and think that they still belong to the Catholic Church? The reason they do so is that the longer they stay in the new false religion, the deeper the infection becomes, the farther they grow away from their possible healing, the more blind they become. As the scriptures tell us, spiritual blindness is the punishment received for following false teachers. It does not make sense, either, to continue to play Russian Roulette with our souls. We must pray to the Holy Ghost for His Guidance, that we must pray to the Holy Ghost for His Guidance, that we may remove ourselves from the horrendous mess that we are in and return to the True Faith. We are experiencing the Abomination of Desolation which was foretold by Christ and the Prophet Daniel. We must flee from it, not worship it, not play games with it, or be a part of it in any sense whatsoever.

At the end of the Easter service, televised at the Vatican in April, 1987, “John Paul II” asked that mankind continue the work of the redemption and then, the big announcement was that everyone present, everyone watching on TV or listening on the radio around the world would be granted a special indulgence. Remember, the True Catholic Church teaches that Christ completed the work of the Redemption on the cross. Redemption is finished, over, completed with that act of His death on the cross. Who is mankind to redeem? From what? To what? And, since when do we receive indulgences over the airways? In the seminary, the question was raised as to whether a person could call a priest and confess his sins over the telephone. The answer is that no sacrament or sacramental can be conducted through any form of electronic transmission or through the mail. These require a personal presence before the priest. Who knows what the new church will dream up next? (Now, for confession, please call Pennsylvania 6-5000 and a recorded message will tell you that a confirmation receipt of your confession over the phone and your penance will be returned by fax machine or back to your recorder. Please leave your number.) What will be the next insanity to which everyone will agree without a flinch or a question? The fish are drowning. They have gobbled up every hook, line and sinker together with the poisonous bait!

As a footnote, I would like to mention a few thoughts with regard to our involvement with the changes during and following the false council which called itself “Vatican II”. With God’s grace, we recognized what it was from the beginning, because we were close to the heart of the Church’s activities. I was a catechetical instructor for our parish for thirteen years, then a teacher in Catholic schools for eight years. My husband is a Fourth Degree Knight of Columbus.

We were both invested into the Third Order Secular, a lay order of the Franciscans. We both took CCD courses. We were both fighting the very appearance of error from the beginning. We listened to lectures of heretics who insulted the saints, the scriptures and God, and were asked to report what was said to the nuns at school. One of these heretics was a priest from Holy Spirit High School in Atlantic City. We were among the first in the Camden Diocese to recognize the changes in the new Catechisms, because we were there when the first books arrived, and were asked to evaluate them. We went personally to the bishop to complain and were told “not to worry....we know all about Father so and so.” (Get back in your pews!) The heretical priest about whom we complained was promoted to “Advanced Theologian” in the diocese. I would still be teaching today and my husband would still be active in the Knights of Columbus if we had decided it was worth giving up our Faith. The year following the last year I taught in the Catholic schools, I received a call from the Secretary to the Bishop of the Camden Diocese who asked if I would be able to teach sixth grade in his parish school. I told him that I could not because they do not have the Catholic Religion in their new textbooks, and that I could only teach the Catholic Religion. He, said, “Of course, I know that, but you can slip it in.” My son did not believe what was actually happening until he saw what the plan was when he was the Chairman of the Liturgy Committee in Toledo, Ohio. Then he saw for himself each and every detail that was planned, how it was

to be implemented and what each next step would be. It was then that he knew that he had to leave or go down with the ship, and that ship was not the Barque of Peter. He did not wish to join the scoffers of Noe in their watery grave. This decision came following six years of study, research and consideration.

Catholics who still hold the Catholic Faith that they were taught make up the Body of the Catholic Church, known as the Mystical Body of Christ. Saint Augustine said that if there are three or four Catholics remaining Faithful to Christ, there is the Catholic Church. They have Christ as their leader and the unchanged and unchanging teachings of His Church as their guide. How many Catholics are there? Certainly very few! Only God knows exactly how many. We are in communication with some of them across the country and overseas. There remain no earthly rulers to lead. During past heresies God raised up great saints to lead the Faithful and to save the situation for God and for His Church. We do not believe that God will raise up any great saints to the occasion today. There is no Saint Athanasius or Saint Augustine today. We do not expect there to be one. This is not just a great heresy. We believe this is the Great Apostasy which Christ himself foretold. True Catholics will become fewer and fewer until the end. We do not have the Mass or the Sacraments here, but they must exist somewhere. The Holy Sacrifice of the Mass is being offered in some prison or in some underground situation in some part of the world. When the final Holy Sacrifice of the Mass is offered, then we shall see the end. In the meantime we can only accept the situation that God has presented to us as he has presented it to us. We cannot change it. We remain at home, live our Catholic lives and pray. We say the Mass prayers from our Saint Andrew's Missals, just as we did when we attended the True Mass. We say the Rosary every day. We say morning prayers, night prayers, the Angelus, The Regina Coeli, Grace before and after meals, evening Holy Hour prayers, read the Bible, read spiritual readings and study. We pray and wait and do our best, with the help of God, to remain in the proper state of preparation. "But this know ye, that if the householder did know at what hour the thief would come, he would surely watch, and would not suffer his house to be broken open. Be you then also ready; for at what hour you think not, the Son of Man will come." (The Gospel of Saint Luke, Chapter 12, verses 39 and 40)

We cannot any longer live our lives as we were once accustomed. We once had the privilege of the Graces of the Sacraments. We could immerse ourselves in our worldly careers, living fairly normal lives. Now, with the contagion and contamination of the world becoming worse day by day, we must separate ourselves from it more completely and devote ourselves to prayer and study as much as possible.

As Saint Athanasius said, "The heretics have the buildings; we have the Faith." They have the whited sepulchers, we have the True Wealth. The hierarchy of today, posing as the leaders of the "Catholic Church", are traitors and apostates. They are wolves in sheep's clothing, imitators all. They are the enemies of Christ, just as were the High Priests, Pharisees, Sadducees, the Sanhedrin and Scribes; as the Jewish hierarchy was His enemy during the first Coming of Christ. They are

scoffing at Him, scourging Him and plotting to put Him to death once and for all. They hate His Church and everything it represents. Their every action proves this. By their fruits, you will know them. They could never fight it effectively from the outside. They knew they could only accomplish their dastardly task from the inside. They have been working on their plan for centuries. Our Lady of La Salette, appearing in the French Alps, September 19, 1846, said that, in the end, Rome would become the Seat of Antichrist and the Church would become obscured. Christ Himself, referring to the end times asked will there yet be Faith on earth when he returned? (“But yet the Son of Man, when he cometh, shall He, think you, find Faith on earth?” The Gospel of Saint Luke, chapter 18, verse 8) This indicates that the number of the Faithful will be small at the time of the Second Coming of Christ. Few will be saved and many will perish. We must pray to the Holy Ghost to Guide us in His Truth. We are bound under obedience to separate ourselves immediately from false teachers and false christs, as Christ commands us. We are also bound to avoid those, even family members, who continue to follow false teachers and continue to belong to any false church. In the meantime, we patiently wait and pray.

One Final thought, one that is filled with heartfelt advice. Stay at home and pray the prayers recommended by the Holy Catholic Church. If you have a Mass Missal printed before 1957, please use it on a daily basis. If you do not, pray that you will find one in a used book store. Do not go to any building for the purpose of adoring God. There is nothing which is pleasing to Him left which operates on an organized basis. Traditional groups offer what appears to be very attractive, Catholic-looking masses, services, etc. They are nothing by imitations. These priests, and so-called bishops have no jurisdiction in the True Church. They operate on their own authority. If they are valid, they are illicit (illegal and unholy). The new ordo sect offers similar Latin mass shows. What is the value of receiving unholy sacraments? There is no spiritual value in “The Mass as any cost” theory. Stay at home and pray. Avoid at all cost the spiritual wolves that lurk about seeking to devour souls. Do not donate a farthing, a pinch of incense or a drop of time to assist any one of them, for you would be aiding a schismatic or a heretic. Do not buy their books, as Catholic as they may seem. What God has given you, He has given you. Please be satisfied with His decision. The Faithful will become fewer and fewer as time progresses. More and more will fall away every day. Hardly any will ever be able to return. Beware of all temptations. The wolf prowls about appearing as a loving sheep. Flee quickly and pray!
